## ॥ अधिसूचना ॥

विश्वविद्यालय कार्यपरिषद् की बैठक दिनांक 06.03.2023 के अध्यक्ष के अनुमति से निर्णय क्रमांक 02 एवं छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय, महानदी भवन, नवा रायपुर अटल नगर, रायपुर से प्राप्त पत्र क्रमांक एफ 3-14/2023/38-2 दिनांक 17.01.2024 के अनुक्रम में नवीन Ordinance No. 200 - PGDEI (Post graduate Diploma in Early Intervention) माननीय कुलाधिपति महोदय द्वारा अनुमोदित को अंगीकृत किए जाने का निर्णय लिया गया, जो निम्नांकित है -

### Ordinance No- 200

#### PGDEI

#### (Post graduate Diploma in Early Intervention)

(E.C. under 06-03-2023)

#### 1. Eligibility :

1.1 A candidate who has passed:

- M.B.B.S./ BAMS/ BUMS/BSMS//BNYS/ or equivalent degree.
- BOT/BPT/BASLP/B.Ed. (S.E.) or equivalent degree.
- B.Sc. Nursing,
- Post graduate in psychology/ social work./ special education/ child development or equivalent degree.

With 50 % aggregate marks in case of general candidate. Relaxation of other category as per applicable of rules and regulation of state govt. and university guideline.

1.2 : The reservation and other relaxation for SC/ST/OBC/PWD and other categories shall be as per the prevailing rules of the state government.

1.3 Age limit : Not exceeding 35 years .

1.4 No of seats: Number of seat will be applicable as per recognition guideline of RCI and approved by the concern university for the session.(At present it will be 12)

#### 1.5 Duration of the course:

The duration of the Course is one academic years,

#### 2. Admission procedure:

Admission shall be made on merit on the basis of marks obtained in the qualifying examination and / or in the entrance examination or any other selection process as per the state government and the university.

#### 3. Attendance:

Eligibility to admit in examination is essential 80% and 100 % in practical work and assignments should be completed and certified by the respective staff prior to the final examination. If due to illness the student is unable to complete the target, production of medical certificate can be considered. However the final decision of allowing for examination will be taken by the competent authority.

#### 4. Assessment

4.1 The examination shall consist of two parts, namely

Part I... Theory and

Part II ... Practicum/.

The classification and division in the theory **part I** will be as under-

1<sup>st</sup> division – 60% and above marks.

2<sup>nd</sup> division- 45% and above but less than 60% marks.

3<sup>rd</sup> division- 33% and above but less than 45% marks.

Fail – Below 33%

In each theory paper the candidate should obtain a **minimum 27%** marks.

The classification and division in the practicum **Part II** will be as under –

1<sup>st</sup> division- 80% and above marks.

2<sup>nd</sup> division – 60% and above but less than 80% marks.

3<sup>rd</sup> division - 50% and above but less than 60 % marks.

Fail – below 50 % marks.

- The theory paper include; Neurobiology, Child development and learning, Assessment Intervention and Evaluation, Therapeutics. Family and community.
- Practical : Case history and development assessment, Therapeutics assessment Intervention and evaluation, Individual family Assessment.
- If any student fails in theory paper he/she will be allowed to appear as ATKT to maximum 1 times in one theory and if he/she is not cleared in practical part only then reappear in all the theory & practical parts again. However a candidate has to clear all the back papers/practical in a maximum duration of one year.

#### 5. Curriculum program implementation:


Syllabus, assessment and examination scheme shall be as per the norms of RCI recommendation and as approved by the BOS Board of studies.

5.1 Every student has to complete practical work as per syllabus approved by BOS. And have to submit a practical copy record. An external examiner will evaluate the student's performance and will also take a viva voce examination in any one part of practical.

5.2 A student shall have to opt for one elective As per provision provided in course

- fees :** The institutions shall charge fee as prescribed by the affiliating body / state government in accordance with the provision of prescribed by RCI as amended from time to time and shall not charge donation, capitation fee etc. from the students.
- All the other relevant rules & regulation will be abounded time to time as per university guideline.
