

	Ordinance No. 6	Para-37- Nil	<p><u>Addition of Serial No. 37 after Serial No. 36</u></p> <p>37. Guidelines for conducting written examination for person with disabilities.</p> <p>I. The facility of Scribe/Lab Assistant will be allowed to any examinee who has disability of 40% or more if so desired by the examinee.</p> <p>II. The examinee will arrange his/her own Scribe /Lab Assistant for the examination.</p> <p>III. Criteria like educational qualification, marks scored, age or other such restrictions for the scribe/lab assistant shall not be fixed, instead, the invigilation system will be strengthened, so that the examinee using scribe/lab assistant do not indulge in practices like copying and cheating during the examination.</p> <p>IV. There will also be flexibility in accommodating any change in scribe/lab assistant in case of emergency. The examinee will also allowed to take more than one scribe for writing different papers especially for languages.</p> <p>V. Examinee with disabilities will be given the option of choosing the mode for taking the examination i.c. in Braille or in computer.</p> <p>VI. The examinee will be allowed to check the computer system one day in advance so that the problems, if any, in the software/system could be rectified.</p> <p>VII. For availing the facility of scribe, the necessary details will be recorded at the time of filling up of the forms. Thereafter for the examinee with disability, examining body will ensure availability of Braille/Computer opted by the candidate as well as suitable seating arrangement for giving examination.</p>

		<p>VIII. The disability certificate issued by the competent medical authority at any place will be accepted.</p> <p>IX. The word "extra time or additional time has been changed to "compensatory time" and the same will not be less than 20 minutes per hour of examination for person who are making use of scribe/lab assistant. All the examinee with disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration which could further be increased on case to case basis.</p> <p>X. The examinee will be allowed to use assistive devices like talking calculator (in case where calculators are allowed for giving exam) tailor frame, Braille slate, abacus, geometry kit, Braille measuring tape and augmentative communication devices like communication chart and electronic device.</p> <p>XI. Proper seating arrangement (preferable of the ground floor) will be made prior to the commencement of examination to avoid confusion of distraction during the day of exam. The time of giving the question paper will be marked accurately and timely supply of supplementary paper will be ensured.</p>
