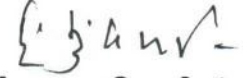

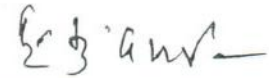

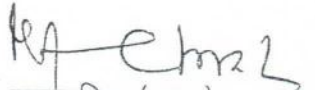

Minimum qualifications and conditions for the post of Professors, Associate Professors and Assistant Professors in University for appointment of persons through Open Advertisement and promotion of working teachers through Career Advancement Scheme (CAS)

1.1.0 RECRUITMENT AND QUALIFICATIONS

1.1.1 The direct recruitment to the posts of Assistant Professors, Associate Professors and Professors in the University shall be on the basis of merit through all India advertisement and selections by the duly constituted Selection Committee as specified in **Section 49 (2) of Chhattisgarh University Adhiniyam, 1973.**

1.1.2 The minimum qualifications required for the post of Assistant Professor, Associate Professor, Professor, Senior Professor, Assistant Librarian, Deputy Librarian, Librarian, Assistant Director of Physical Education and Sports, Deputy Director of Physical Education and Sports and Director of Physical Education and Sports, shall be as specified by the UGC

1.1.3 The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/ SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions.

Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil./ Ph. D. 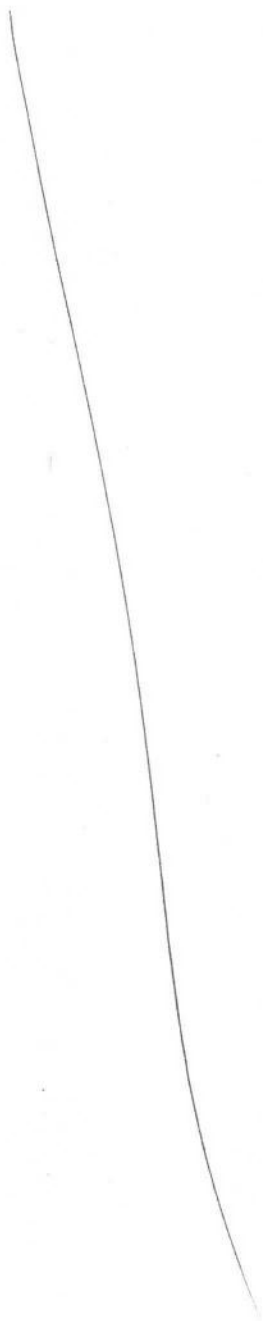

SELECTION PROCEDURES AND SCORES FOR ACADEMIC PERFORMANCE INDICATORS (APIs) IN RECRUITMENTS AND CAREER ADVANCEMENT SCHEME (CAS) PROMOTIONS OF UNIVERSITY TEACHERS AND OTHER ACADEMIC STAFF	
1.0	SELECTION PROCEDURES
1.1	The overall selection procedure shall incorporate transparent, objective and credible methodology of analysis of the merits and credentials of the applicants based on the weightage given to the performance of the candidate in different relevant parameters and his/ her performance on a grading system proforma, based on Tables 1, 2, 3A, 3B, 4, and 5 of Appendix.
	In order to make the system more credible, university will assess the ability for teaching and/ or research aptitude through a seminar or lecture in a classroom situation or discussion on the capacity to use the latest technology in teaching and research at the interview stage. These procedures will be followed for both the direct recruitment and the CAS promotions, wherever selection committees are prescribed in the Regulations.
1.2	The university adopts these Regulations for selection committees and selection procedures incorporating Tables 1, 2, 3A, 3B, 4, and 5 of Appendix at the institutional level to be followed transparently in all the selection processes. The university shall devise self-assessment-cum-performance appraisal forms for teachers in strict adherence to the Tables 1, 2, 3A, 3B, 4, and 5 of Appendix as specified in the UGC Regulations and the amendments from time to time.
1.3	The Internal Quality Assurance Cell (IQAC) shall act as the documentation and record-keeping Cell for the University, including assistance in the development of Assessment Proforma based on the UGC Regulation 2018.
1.4	The Assessment of the performance of University teachers for the CAS promotion will be based on the following criteria: <ul style="list-style-type: none"> i. Teaching-Learning and Evaluation: The commitment to teaching based on observable indicators such as being regular to class, punctuality to class, remedial teaching and clarifying doubts within and outside the class hours, counseling and mentoring, additional teaching to support the university as and when the need arises, etc. Examination and evaluation activities like performing of examination supervision duties, question-papers setting for university examinations, participation in the evaluation of examination answer scripts, conducting examinations for internal assessment as per the schedule to be announced by the University at the beginning of each Academic Session and returning and discussing the answers in the class. ii. Personal Development Related to Teaching and Research Activities: Attending orientation/ refresher/ methodology courses, development of e-contents and MOOC's, organizing seminar/ conference/ workshop/ presentation of papers and chairing of sessions/ guiding and carrying out research projects and publishing the research output in national and international journals etc. iii. Administrative Support and Participation in Students' Co- curricular and Extra-curricular Activities.
1.5	The following three-step process is recommended for carrying out assessment for promotion under the CAS at all levels: <p>Step 1: The University teachers shall submit an annual self-appraisal report in the prescribed Proforma based on Tables 1 to 5 of Appendix. The report shall be submitted at the end of every academic year, within the stipulated time. The teacher will provide documentary evidence for the claims made in the annual self-appraisal report, which will be verified and forwarded by the HOD to the University.</p>

1.8	The criteria for promotions under Career Advancement Scheme laid down under the UGC Regulations shall be effective from the date of notification of the UGC Regulations. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify shortly under the existing regulations, a choice may be given to them, for being considered for promotions under the existing Regulations. This option can be exercised only within three years from the date of notification of the Regulations.
2.0	A teacher who wishes to be considered for promotion under the CAS may submit in writing to the university, within three months in advance of the due date, that he/ she fulfils all the requirements under the CAS and submit to the university the Assessment Criteria and Methodology Proforma as evolved by the university duly supported by all credentials as per the Assessment Criteria and Methodology guidelines set out in the Appendix. In order to avoid any delay in holding the Selection Committee meetings for various positions under the CAS, the University should initiate the process of screening/selection, and complete the process within six months from the receipt of application. Further, in order to avoid any hardship, the candidates who fulfill all other criteria mentioned in the Regulation, as on and till the date on which this regulation is notified, will be considered for promotion under the provision of existing Regulation 134 of the University.
2.1	The CAS promotion from a lower stage to a higher stage of Assistant Professor shall be conducted through a "Screening-cum-Evaluation Committee", following the criteria laid down in Table I of Appendix.
2.2	<p>The "Screening-cum-Evaluation Committee" for CAS promotion of Assistant Professors/ equivalent cadres in Librarians/ Physical Education and Sports from one level to the other higher level shall consist of:</p> <p>The Vice-Chancellor shall be the Chairperson of the Committee;</p> <p>The Dean of the Faculty concerned;</p> <p>The Head of the Department/ Chairperson of the School; and</p> <p>One subject expert in the subject concerned nominated by the Vice-Chancellor from the University panel of experts.</p> <p>Note: The quorum for the committee shall be three which will include one subject expert/ university nominee.</p>
2.3	<p>The Screening-cum-Evaluation Committee on verification/ evaluation of grades secured by the candidate through the Assessment Criteria and Methodology Proforma designed by the university based on UGC Regulations and as per the minimum requirement specified:</p> <p>(a) In Appendix, Table 1 for each of the cadre of Assistant Professor;</p> <p>(b) In Appendix, Table 4 for each of the cadre of Librarian; and</p> <p>(c) In Appendix, Table 5 for each of the cadre of Physical Education and Sports</p> <p>The Committee shall recommend to the Executive Council of the University about the suitability for the promotion of the candidate (s) under CAS for implementation.</p>

2.6	For the promotion under the CAS, the applicant teacher must be on the role and in active service of the University on the date of consideration by the Selection Committee.
2.7	The candidate shall offer himself/ herself for assessment for promotion, if he/ she fulfill the minimum grading specified in the relevant Assessment Criteria and Methodology Tables, by submitting an application and the required Assessment Criteria and Methodology Proforma. The promotion is recommended by the screening-cum evaluation committee.

Eligibility:

Assistant Professors who has completed five years of service in Academic Level 11/Senior Scale.

A Ph.D. Degree in the subject relevant/allied/relevant discipline.

Has done any two of the following in the last five years of Academic Level 11/Senior Scale: Completed a course / program from amongst the categories of Refresher Courses/Research Methodology/ Workshops/ Syllabus Up-gradation Workshop/ Teaching-Learning-Evaluation/ Technology Program / Faculty Development Program of at least two weeks (ten days) duration (or completed two courses of at least one week (five days) duration in lieu of every single course/program of at least two weeks (ten days) duration), or, completed one MOOCs course in the relevant subject (with e-certification); or contribution towards the development of e-content in 4-quadrant (at least one quadrant) minimum of 10 modules of a course/contribution towards the development of at least 10 modules of MOOCs course/ contribution towards conduct of a MOOCs course during the period of assessment.

CAS Promotion Criteria:

6.0 Discretionary award of advance increments for those who enter the profession as Associate Professor or Professor with higher merit, high number of research publications of high quality and experience at the appropriate level, shall be within the competence of the appropriate authority of the University based on the recommendations of a selection committee while considering the case of individual candidates in the context of the merits of each case, taking into account the pay structure of other teachers in the faculty and other merit- specific factors.

Discretionary award of advance increments is not applicable to those entering the profession as Assistant Professor/Assistant Librarian/Assistant Director of Physical Education and Sports and to those who are entitled for grant of advance increments for having acquired a Ph. D., M. Phil. or M.Tech. and LLM degree.

However, those entering the service as Assistant Professor/Assistant Librarian/Assistant Director of Physical Education and Sports, having a post-doctoral teaching/ research experience, after obtaining a Ph.D. degree and proven credentials, may be eligible for discretionary award of advanced increments to be given to the person, as decided and recorded by the Selection Committee in the minutes of its meeting.

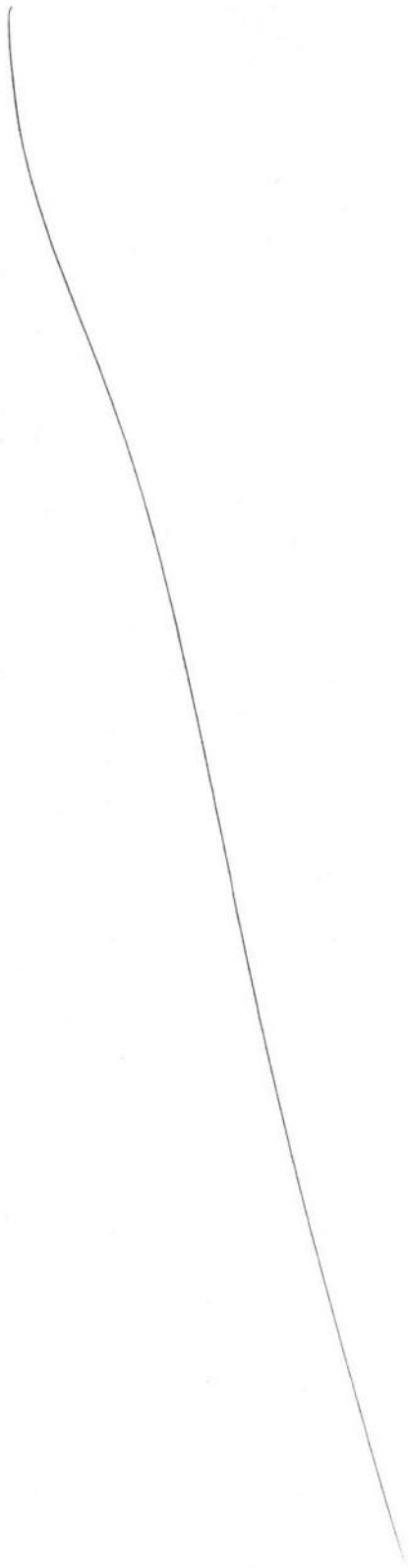
