



Guidelines for PhD course Work Examination, 2014

- The scheme of Ph.D. Course Work Examination will consist of two papers, namely Paper-I based on research methodology etc. and Paper-II based on review of literature/project in the area of proposed research work.
- Paper-I: It will include 30 objective (MCQ) and 8 subjective (Short answer using 50 to 100 words) questions in the ratio 60:40.
- Paper-II: It has two parts. The first part is the review/project (write-up: up to minimum 25 typed pages in 1.5 space including references) itself and it will carry 50 marks. The second part includes a seminar to be delivered by the candidate based on the first part of this paper. It will also carry 50 marks. The candidate has to secure minimum 50% marks in both the parts.
- The candidate has to secure 50% or more marks independently in both papers to qualify the PhD Course work.

1)	Paper-I	<p>a) The examination for this paper will be conducted in the research center located on the Pt. Ravishankar Shukla University, Raipur campus only. The candidates enrolled for PhD course Work in college centers will appear at their pre-allotted (by the University) research centers located on the Pt. Ravishankar Shukla University, Raipur campus. Duration of the Examination will be 2 hours (11:00 AM to 01:00 PM).</p> <p>b) All Candidates will have to submit their forms and get their admit card from their allotted research centers on the Pt. Ravishankar Shukla University, Raipur campus.</p> <p>c) The responsibility of setting of question paper, conduct of examination and evaluation of the answer books lies on the Chairman of the DRC of each Research center on the Pt. Ravishankar Shukla University, Raipur campus.</p> <p>d) Each answer book will be evaluated by at least two examiners independently.</p> <p>e) The questions will be based on the already approved syllabus for each subject.</p>
2)	Paper-II	<p>a) All candidates will submit their review work/project report at the designated research center on/or before the last date declared by the University on the Pt. Ravishankar Shukla University, Raipur campus.</p>

- b) The date of seminar/presentation will be declared by the University/Chairman, DRC of the designated Centre on the Pt. Ravishankar Shukla University, Raipur campus.
- c) The presentation will be carried out only at the allotted centers located on the Pt. Ravishankar Shukla University, Raipur campus.
- d) Each candidate will have to present their review/project work preferably using Power Point slides on specified date and time.
- e) The duration of presentation will not exceed 20-30 minutes including discussion.
- f) The presentation will be assessed by a three member's committee consisting of the Chairman of the DRC (or its nominee), One subject expert not below the rank of a Associate Professor and the PhD Supervisor of the candidate.
- g) The evaluation committee will be constituted by the Chairman, DRC with the approval of the Vice-Chancellor.

General guidelines

- a) After evaluation DRC will prepare results and submit to academic section after declaration of the result by the University, DRC will forward the prescribed application of the qualified candidates to the Academic Section of the University for Further Necessary Action.
- b) Successful candidate under the guidance of his/her supervisor will submit the synopsis to academic section after presentation in the DRC and this will be forwarded by the Chairman DRC and after submission of the synopsis, the University will put the application of the candidates before the RDC for final consideration and approval of the registration.
- c) Those candidates who will fail to qualify the PhD Course work will be given another chance to undertake the Course Work and to appear at the Examination again after a lapse of at least six more months.
- d) It will be mandatory for each candidate to have 75% attendance in the Course Work (Paper-I).
