विश्वविद्यालय कार्यपरिषद् की बैठक दिनांक 18.02.2024 के अध्यक्ष की अनुमति से अन्य निर्णय क्रमांक-03 एवं छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय, महानदी भवन, नवा रायपुर अटल नगर, रायपुर से प्राप्त पत्र क्रमांक एफ 3-15/2024/38-2 दिनांक 31.05.2024 के अनुक्रम में नवीन Ordinance No. 208 - "Integrated Teacher Education Program (ITEP)(B.Sc. B.Ed. Course)" माननीय कुलाधिपति महोदय द्वारा अनुमोदित को अंगीकृत किए जाने का निर्णय लिया गया, जो निम्नांकित है -

Ordinance No- 208

Integrated Teacher Education Program (ITEP)

(B.Sc. B.Ed. Course)

(E.C. under 18-02-2024)

I. PREAMBLE

1. The four-year integrated program aims at integrating general studies comprising science also known as 'Bachelor of Science and Bachelor of Education' (B.Sc. B.Ed.), and professional studies comprising foundation of education, pedagogy of school subjects, and practicum related to the tasks and functions of a school teacher. It maintains a balance between theory and practice, and coherence and integration among the components of the program, representing a wide knowledge base of a secondary school teacher. The program aims to prepare teachers for the Upper Primary and Secondary stage of education.
 2. The program contents related to Physics/ Chemistry/ Mathematics/ Botany/ Zoology offered in B.Sc.B.Ed. are equivalent to that of B.Sc. (PCM/CBZ) of Pt. Ravishankar Shukla University, Raipur. The program contents related to education components in B.Sc.B.Ed. are equivalent to B.Ed. The Course contents of the professional education component are equivalent to that of B.Ed. of Pt. Ravishankar Shukla University and are following the norms and regulations for the B.Sc. B.Ed. Program prescribed by the NCTE (2021).
 3. This degree B.Sc. B.Ed. is equivalent to B.Sc. and B.Ed. degrees of the Pt. Ravishankar Shukla University. Students who pass this program are considered eligible to pursue a Master's Degree.
- #### II. ELIGIBILITY AND EQUIVALENCE FOR ADMISSION FOR B.Sc. B.Ed. COURSE.

Page 1 of 4

1. Candidates seeking admission to the B.Sc. B.Ed. program should have passed the Senior Secondary/+2 examination with at least 50% marks in the aggregate.
2. The reservation and relaxation in the marks for SC/ST/OBC/PWD and other categories shall be as per the rules of the state government/central government policies.
3. Norms and standards of a four-year integrated program leading to B.Sc. B.Ed. Degree shall be according to National Council for Teacher Education (NCTE) and ITEP guidelines and regulations.
4. Candidate will be eligible for admission to Mathematics (PCM) Group if the candidate has qualified qualifying examination with Physics, Chemistry and Mathematics and for admission to Biology Group (CBZ) Group if the candidate has qualified qualifying examination with Chemistry Botany and Zoology. Out of the total number of seats, 50% will be allotted to each group (50% PCM, 50%CBZ).
5. Out of the total number of seats available for each program, the reservation will be made as per the State Government/central government rule in force from time to time.

III. ADMISSION PROCEDURE

1. Admission will be through an entrance examination conducted by a competent agency.
2. At the time of admission in the program, the student will need to indicate their selection of the subjects to be pursued for the discipline options and the accompanying pedagogy specializations for which they are applying, and those may be assigned based on the order of merit and availability of the seats.

IV. EXAMINATION PATTERN

1. Course Duration and attendance

- The B.Sc. B.Ed. Program shall be of four academic years or eight semesters including school-based experience and internship in teaching. Any student-teacher who is unable to complete any semester or appear in any semester-end examination shall be permitted to complete the program within a maximum period of six years from the date of admission to the program.
- In a semester, there shall be at least 125 (one hundred and twenty-five) working days, excluding the period of admission but including the period of examinations.
- The working duration/period shall be 40 hours per week.
- The minimum attendance of student-teachers shall have to be 80% for all course work and practicum, and 90% for field-based experience or school internship or teaching practice separately.

2. Change of Stream and Institutions





Once chosen, a change of stream and an institution will not be permitted under any circumstances during the program.

3. Maximum and Minimum Marks

- Candidate must obtain a minimum of 40% marks in each theory.
- Candidate must obtain a minimum of 50% marks in each practical.
- Candidate must obtain 40% marks in theory and sessional.
- Candidate must obtain at least 50% marks in each sessional.
- If a candidate fails in sessional marks, he/she has to appear in the internal examination again.

4. Promotion to next semester

- Any candidate fails in not more than two subjects will be treated as ATKT.
- The candidate will be allowed to appear in ATKT examination 1+2 (one main and two ATKT exams).
- Nobody can escape from ATKT. It is mandatory to clear the ATKT examination.
- Students who have been promoted to the next semester shall avail the chance to clear the backlog papers only in the next ATKT examination.
- A candidate must clear all the backlog papers (ATKT) before the commencement of the 8th semester. If a candidate fails to clear all the ATKT papers will not be promoted to the 8th semester.

5. Award of Division

1. Successful candidates will be awarded division based on the aggregate marks of all the Core Courses, Pedagogy Courses and Courses on Developing Teacher Sensibilities as per the following
 - i. First Division 60% or more
 - ii. Second Division 45% or more (but less than 60%)
 - iii. Third Division 36% or more (but less than 45%)

(NOTE: - Grade pattern will be applicable as suggested by NCTE.)
2. Changes in Statutes/ Ordinances/ Rules/ Regulations/ Syllabus and books may from time to time be made by amendment or remaking and a candidate shall, except in so far as the University determines otherwise, comply with any change that applies to the semester she/he has not completed at the time of change.
