Provided he: she secured at least 50% marks in the above examination (relaxation to SC/ST/OBC as per University norms).</li> <li>The course structure along with scheme of examination shall be prescribed in the Board of Studies in Geology.</li> </ol>	<ol> <li>The duration of the P. G. Diploma in Remote Sensing &amp; Geographic Information System shall be of one academic year and is in coherence as per the Memorandum of Understanding between Pt. - Other provisions not covered herein shall be as per the University Ordinances. No. 5 and

- A candidate shall be declared successful if he/she obtains at least 50% of the total aggregate marks. A candidate is required to pass in the practical and theory examinations, by obtaining a minimum of 50% marks, separately.
- The declaration of examination result shall be as per the University norms.
- An examinee, who fails in theory papers or in practical/dissertation, can appear in the two (02) forthcoming annual examinations on payment of the examination fee prescribed by the University, as an ex-student without being required to attend classes of regular study. In case of candidate who has submitted dissertation and declared pass shall not be required to submit the project report again while appearing as an ex-student.
- The revaluation provision is available only in theory papers, as per the University norms.
- Other provisions not covered herein shall be as per the University Ordinances No. 5 and 6.
