
CERTIFICATE COURSE IN DECENTRALIZED PLANNING

(E.C. under 10-08-2021)

1. The objectives of the above two certificate courses are to provide opportunity to students for pursuing career in Panchayati Raj and Rural Development.
2. The duration of two Certificate Courses (i) Livelihood Planning and Supply Chain Management and (ii) Decentralized Planning shall be of three months each.
3. The eligibility criteria for admission to these certificate courses shall be 10+2 examination in any stream of any board in India, which has been recognised by this University.
4. The course structure along with scheme of examination shall be prescribed by the Board of Studies in Regional Studies.
5. A candidate shall be declared pass if he/she obtains at least 50% of aggregate marks. A candidate is required to pass in the project and theory examinations separately by obtaining not less than 50% marks.
6. A candidate shall be declared pass in second division if he/she obtains 50% or above and less than 60%, A candidate shall be declared pass in first division if he/she obtains 60% or more and less than 75%, and shall be declared pass with merit if he/she obtains 75% or more.

7. An examinee who fails in theory paper/ papers or in project may appear in theory /project/ in forthcoming two consecutive examinations on payment of fee prescribed by the University, as an ex-student without being required to attend the classes of regular study. Provided that a candidate who has submitted project report/dissertation and declared pass shall not be required to submit project report again while appearing as an ex-student.
8. If an examinee is failed in theory paper/papers and passed in project work he/she is required to appear in theory paper/papers only. Similarly an examinee is failed in project work and passed in theory paper/papers he/she is required to appear in project work only
9. There shall be revaluation only in theory papers.
10. Other provisions not covered herein shall be as per the University Ordinances No 5 & 6.
