Special attention is given to power dynamics, inclusivity, and methods for strengthening community capacity. By equipping students with the skills to conduct meaningful research, this course fosters a commitment to participatory action and policy change that leads to long-term community empowerment.

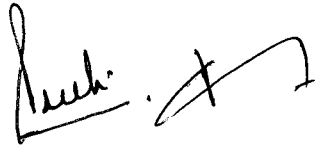
