



# Faculty Induction Program - (GURU-DAKSHATA) (11.07.2023 - 17.08.2023)

Faculty Induction Program (GURU-DAKSHTA) of one month from 11/07/2023 to 17/08/2023 was conducted under the ambitious plan of the Ministry of Education, Pt. Madan Mohan Malaviya National Mission on Teachers and Education. The main objective of this program was to provide information related to technical and educational aspects of higher education to newly appointed assistant professors in colleges and universities. Forty-four assistant professors from two states namely Chhattisgarh and Madhya Pradesh participated in this program. Out of which 03 were from Library Science, 02 from Chemistry, 07 from English, 03 from History 06 from Commerce, 03 from Physics, 02 from Mathematics, 03 from Botany, 02 from Hindi, 05 from Physical Education, 01-01-01 Sports, Computer Application, Electronics, Law and 02-02 from Zoology, Psychology respectively. Among them, 30 participants were male and 14 participants were female. All the ten modules of the program had been carefully designed to incorporate the four coordinates (e-tutorials, econtent, web resources and self- assessment) prescribed by UGC. Eminent educationalists and experts of various subjects (List enclosed) made the participants aware of the values of the society, new education system, research and new techniques through effective and inspiring lectures and their doubts were resolved. Objective type online test of 10 marks at the end of each module as well as e-content development, brainstorming, assignment, seminar, microteaching etc. from each module were conducted by the organizers and were successfully attended by the participants. The entire program was conducted on Google Meet platform every day in four sessions from 10.30 am to 5.30 pm.

DAY 1, 11-07-2023


#### Session I (10.30-12.00) Inaugural Function

Ravishankar Shukla University, Raipur were also grace the occasion. The Programme commenced by welcoming them, which was followed by Introduction of the Participants, Prof. Preeti K Suresh gave detailed information regarding the 28 days Online Faculty Induction Program (Guru Dakshta) to the participants. In this session Course Coordinator Prof. D.P. Bisen and Dr. Arvind Agrawal Welcomed all the Guest, Resource persons and participants. All the participants gave their short introduction. Course Coordinator Prof. D.P. Bisen discussed the objectives of Faculty Induction Program (Gurudakshta) and explained the time table and various tasks to the participants.

#### Session II (12:15 to 13:45)



**1. Prof. A. K. Bakhshi**, Vice Chancellor of PDM University, Bahadurgarh, Haryana, delivered an excellent talk on "Current Challenges and Opportunities in Indian Higher Education - Implications for the everyday classroom"

He described the topic in a very simple language with impressive power point presentation. He discussed the whole topic in three parts: I. Excellence in higher education II. Challenges in the 21st century III. Age of Artificial Intelligence. He also indicated the real challenges and opportunities of Indian higher education in present time and also encouraged to think different and for creative innovations.

#### Session III (14.15 to 15.45) & Session IV (16.00 to 17.30)



**2. Prof. Sudhanshu Bhushan**, Professor & Head, Department of Higher and Professional Education, National Institute of Education Planning and Administration, New Delhi is delivered two lectures:

1. "Evolution of the Higher Education Sector of India (Indian Higher Education Structure, Function and proposed reforms under NEP2020)" 2. "National and Global Trends in Higher Education"

These are some points of discussion of this session

- 1. He spoke about evolution of higher education system in India from ancient time to modern era, and explained the impact of various models of European Universities like London model, German model and Oxford, Cambridge Model on education system in India.
- 2. He gave brief insight about role of several commissions, acts and collective collegial model of governance on development of modern Universities in India.
- 3. Prof. Kumar threw requisite light on various types of educational institutions and their functioning, governance and importance.
- 4. He also emphasized on the enhancement of Gross Enrollment Ratio.
- 5. He discussed briefly the national and global trends in higher education where he explained the impact of Neo-liberal reforms on higher education because of which public

funding is continuously declining. He further introduced an idea of innovative funding and self-resource generation for education institution.

- 6. Change in governance of higher education from collegial model to bureaucratic and entrepreneurial model has been discussed in this session.
- 7. Prof. Kumar threw requisite light on various constraints and loop holes of higher education system in India. He also explained the government plannings and policies to enhance the quality of education system in India as per the global trends.
- 8. He enlightened the session with the idea of Internationalisation of higher education, diversity and employability based learning in educational institution.
- 9. He revealed various aspects of NEP 2020 related to research and governance in education institution to uplift the education system in India.





DAY 2, 12-07-2023

#### Session I (10:30 to 12:00)



**3. Prof. B.S. Thakur**, Professor and Head, SoS in Mathematics, Pt. Ravishankar Shukla University, Rapur, He delivered lecture on University Act, Statutes, Ordinance role and importance in governance, in which he explained in detail the organization, structure, work and power of the university. Difference

between College and University under the Objectives of Higher Education, Concepts and views of Nehru ji and Kothari ji in the context of University, History of University, Spectrum of Higher Education, Types of University, University Act, Statutes, Ordinance etc. were discussed in detail. At the end of session questionnaire took place and vote of thanks is given by the chairperson.

#### Session II (12:15 to 13:45)



**3. Prof. Manikrao M. Salunkhe**, Vice Chancellor Bharati Vidyapeeth, Pune, delivered two lectures on the topic entitled "The Role of University Act, Ordinance, statutes, Planning and Development in Governance with Special Reference to Central University of Rajasthan"

**During second session** Prof. Salunkhe enlighted the participants about various University acts, progress in establishment of various Universities from 1857 to till date, planning and development of University Governance system for quality management

**In second session** Prof. Salunkhe has given brief insight of brand strategy and brand management of central University of Rajasthan. He spoke about various programs in university, planning for university building, faculty appointment, student placement etc. He also spoke about the evolution of education policy.

#### Session III (14:15 to 15:45)



**4, Prof. Sarjerao Nimse** Sir has taken third session and spoke about the regulations 2f and 12B of the UGC Act. He also said that Section 2(f) in The University Grants Commission Act, 1956 University means a University established or incorporated by or under a Central Act, a Provincial Act or a State Act, and includes any such institution as may,

in consultation with the University concerned, be recognized by the Commission in accordance with the regulations made in this behalf under this Act and 12B is Prohibition regarding giving of any grant to a University not declared by the Commission fit to receive such grant. Then he went through in detail about the NEP 2020, its bullet points, various advantages disadvantages etc.

#### Session IV (16:00 to 17:30)



**5. Dr. S. Rama Devi Pani**, Editor, University News New Delhi, delivered two lecture on the topic entitled "History of one's own University / college"

Fourth and the last session of the day was given by Dr. S Rama Devi Pani who discussed on the topic history of one's own university

/college/ institute. She stated that the first true university in the West was founded at Bologna

late in the 11th century. It became a widely respected school of canon and civil law. The first university to arise in northern Europe was the University of Paris, founded between 1150 and 1170. It became noted for its teaching of theology, and it served as a model for other universities in northern Europe such as the University of Oxford in England, which was well established by the end of the 12th century. The Universities of Paris and Oxford were composed of colleges, which were actually endowed residence halls for scholars. She further talks about NAAC, AIU, NEP 2020, UGC act, CSIR,AICTE in detail.

#### DAY 3, 13-07-2023

#### Session I (10:30 to 12:00) & Session II (12:15 to 13:45)



**6. Prof. Anil Kumar,** delivered a lecture emphasizing the crucial role of teachers in university education and the integration of experiential learning under the NEP 2020. Prof. Kumar highlighted the shift towards student-centred learning, where teachers serve as facilitators and mentors. He stressed the importance of creating engaging classroom environments and incorporating hands-on experiences to

enhance critical thinking. Prof. Kumar also emphasized the use of technology and continuous professional development for teachers. His insights offer guidance for educators and policymakers in shaping the future of higher education in India. Prof. Kumar highlighted the significance of regulatory bodies, such as the Ministry of Education at the central and state levels, in setting standards and policies for universities. These bodies ensure compliance with guidelines, maintain educational quality, and promote the overall development of institutions. Prof. Kumar also emphasized the role of quality assessment mechanisms in evaluating and accrediting institutions. Accreditation agencies play a vital role in ensuring universities meet defined benchmarks, enhancing their reputation and facilitating continuous improvement. Writing of research proposal basic components, title of the Writing of research proposal basic components, title of the research, aim, objectives, methodology, review of literature, question and hypothesis, Gantt chart/timetable, timeline, bibliography reference, difference between bibliography and references budgets, avoid plagiarism, Annexure, explain your finding in more details, conclusion, problem and solution etc. All the sessions struck the perfect balance between informative and interactive. All the tips that were given felt directly applicable and often gave us the confidenceThe Speakers did a great job to engage everyone - there was a lot to learn from them

#### Session III (14:15 to 15:45) & Session IV (16:00 to 17:30)



**7. Dr. Prashant Srivasatava**, Dean Student Welfare Hemchand Yadav University, Durg, delivered two lectures related to "Schemes under UGC, ICSSR, ICHR, DBT and Any other Funding Agencies including NGOs that has relevance to Higher Education" In his first lecture Dr. Srivastava discussed "HOW TO WRITE RESEARCH

PROPOSAL". He spoke various aspects of research proposal, how we should make the research proposal and all the important things which is necessary to write the research proposal, their basic components, problems and their solution. He also discussed about format such as MLA and APA to write the references. He interacted with participants. In the 4th session he delivered lecture about the "SCHEMES UNDER UGC, ICSSR, DBT AND ANY OTHER FUNDING AGENCIES INCLUDING NGOS THAT HAS RELEVANCE TO HIGHER EDUCATION" in which participants has nourished by various grants provided by UGC, CSIR, DBT, USA-india Fulbright scheme, commonwealth academic staff fellowship, UGC-BSR faculty fellowship, NGOs, and so on. He also explained the eligibility criteria for the application of research projects etc.

- **8. Dr. Jayanti Dutta Roy**, Dy. Director, UGC-HRDC, Panjab University, Chandigarh, delivered following two lectures:
- (I) "Considerations for designing the curriculum"
- (II) "Framing curricular objectives and organization of content, co-connecting content with appropriate learning resources,

pedagogical principal and assessment; integrating and interlinking courses"

#### Session-I

She delivered lecture on the topic "Consideration for designing the curriculum." She explained briefly preparations for the class. She also explained about the design of curriculum etc.

**9. Prof. Anil Kumar**. He discussed the choice Based Credit System. He expounded why CBCS came into existence. Tradition higher education system was rigid and faulty. He showed Sample CBCS pattern and Rajiv Gandhi Proudhyogiki Vishwavidyalaya, Bhopal. He also highlighted on the process of evaluation. He explained how to combine different core

subjects for skill enhancement.

#### Session IV (16:00 to 17:30)



**10. Prof. Megha M. Uplane**, Department of Education Savitribai Phule University Pune, was the speaker and she delivered her lecture on "Idea of curriculum and Prospective on Curriculum". She began her topic with various definitions, Elements of Curriculum design. Under the elements of Curriculum design, she threw light on assessment and evaluation. Dr.

Uplane expounded the chief characteristics of a good curriculum. It should be designed completely for the fulfillment of need of people various determinants of curriculum was also detailed by her. The two types of curriculum model such as the Tyler model and Hilda Taba's model were described. Five theoretical perspectives on curriculum such as the traditional, the experiential perspective, the discipline's perspective (structure of disciplines), the behavioural perspective and the constructivist perspective were explained by the speaker.

DAY 5, 18-07-2023

#### Session I (10:30 to 12:00)



**13. Dr. Vinayak Despande** spoke on the topic "Idea of the Choice Based Credit System opportunities and challenges of implementation" He stared his lecture with the basic concept national education policy (NEP). He discussed about the how-to bring NEP in college/university as well as how to try to understand syllabus and curriculum and also talked about

multidisciplinary through academic bank of credit system. His told that CBCS has been given a

platform for the students, its purpose it that the student will able to learn according to their capacity, as well as acquire knowledge, mainly for their evolution, creativity and skill development, CBCS system has been made. His discussed about how to calculate credit like lecture/tutorial- one hour per weak is equal to one credit and practical- two hour per weak is equal to one credit. Example:

**12. Dr. Jayanti Dutta** Madam spoke on the topic "Objective Test/Question Answer Session". she discussed how to teacher interact with students through the question answer/objective test and discussed bloom's taxonomy in detail. She also discussed us how can we use this Bloom's taxonomy in class room. She asks question with us what kind of change took

place in teaching students before and after knowing bloom taxonomy. She discussed what is the importance of question ask teacher to students. At the end of lecture Dr. Jayanti dutta madam said that you should train your students and teach your students how to ask questions and how to get rich top level of students.

**13. Dr. Pragya Kulkarni** delivered lecture on the topic "Taxonomies of Instructional Objectives: Blooms Taxonomy and Revised Blooms Taxonomy" she discussed detail of bloom taxonomy, what is bloom taxonomy and she told effective teaching-learning process through- (1) curriculum planning (2) different instructional method (3) different

assessments practices. dr. pragya madam told us the main focus of blooms taxonomy is to improve students learning and teaching. She discussed how to bloom taxonomy help in how to identify slow learner and fast learner and taking class for slow learner, our lesson plan, preparation etc. She also discussed the roles of teacher and roles of students in classrooms. She told us the role of teacher is direct, tells, shows, examines, questions, guide, observe, organised, extend, analyse, creating and evolute and the student role in classroom like respond, remember, define, discuss, debate, calculate, argue etc. At the end of lecture Pragya mam interacted with participants and answered their queries.

14. Prof. P. K. Ahluwalia delivered his lecture on the topic "Opportunities and challenges of CBCS in comparison to Annual and semester-based system" He stared his lecture with the basic concept of national education policy and national higher education qualification framework (NHEQF). He has discussed on the examination system of semester pattern and annual pattern and which pattern is the best for

students and ask with us. He told about CBCS and also told how this CBCS system is beneficial for the students.


#### VALEDICTORY, FEEDBACK and CONCLUDING SESSION




