The minutes of the meeting are as follows:

- 1. The session started with a gracious greeting and welcome to all the members and guests present in the meeting by the faculty member of IIC, Dr. Govind Prasad Sahu introducing all the external members and special invitees in the meeting.
- 2. Prof. Kavita Thakur, President of the Institute Innovation Council, Pt. Ravishankar Shukla University (IIC PRSU) gave a presentation to highlight various activities done under the council in the previous calendar year 2022-2023. She informed that in the previous calendar year, 16 activities have been organized in the university including national conferences, workshops, celebrations of important days (e.g. world entrepreneurs' day, etc.), industry technical visits, impact lectures, etc. She informed the council that IIC-PRSU got a one-star rating and a letter of appreciation for the calendar year 2022-2023. She emphasized active roles for both internal and external members to ensure effective collaboration and activities to enhance the star rating of IIC-PRSU in the current calendar year. She updated the council regarding activities done so far for the calendar year 2023-2024. In the first quarter, 19 activities have been organized.
- 3. Prof. Sachchidanand Shukla, Vice Chancellor, Pt. Ravishankar Shukla University, Raipur, emphasized the central goal of the IIC PRSU to foster a culture of innovation among students. He assured that a fully functional section 8 company will be established to achieve the goals of IIC PRSU. He emphasized innovation, research, productivity, skill, and ability enhancement of students under the IIC-PRSU. He inspires IIC to follow an annual activity calendar and to design programs that leverage expertise from different domains.
- 4. Dr. Deependra Singh (Coordinator, IIC PRSU) invited and interacted with the external members.
- 5. Special invitee faculty members of the university Prof. Kallol K Ghosh, Prof. A.K. Shrivastava, and Prof. K. K. Sahu shared their valuable thoughts for enhancing productivity and attaining the goals for IIC PRSU.
- 6. Mr. Dilip Mohanty, Chairman, HRM, Jaiswal NECO, Raipur expressed his perspective, noting that the IIC should connect people from finance and industry to nurture budding entrepreneurs. He expressed his support for sponsoring students of the university for industrial visits. He also encouraged organizing soft skill/training workshops for students to enhance the employability of the students. He expressed financial assistance from the NECO for such workshops. He suggested to invite successful entrepreneurs to demonstrate their business models among students. He stressed industry-academia interaction and suggested that people from the industry should also be invited as resource persons and guests in the training and workshop programs. He also suggested inviting and exploring collaboration with bankers and getting financial support as CSR.
- 7. Mr. Sanjeev Jain said that global warming, climate change, and environmental and energy literacy are very hot topics today. Lots of activities are being undertaken by different ministries. He offered his generous support to organize the energy-environment literacy program. He suggested to educate and train students to participate in various programs by











the Ministry in different sectors like e-mobility, green hydrogen, etc. He suggested that industry academy interactions must be increased with industry exposure to students. With the collaboration of CREDA, he pledged his support to organize various activities such as awareness programs, power generation plant visits, and exposure to renewable energy sectors. He emphasized that energy storage and green hydrogen are new avenues for the next generation, and students should be motivated to explore opportunities in these sectors under the umbrella of IIC PRSU.

- 8. Mr. Rahul Mishra also emphasized industry-academic collaboration and collaborations with international universities like universities from Singapore, Malaysia, and Australia for student/faculty exchange and joint certification programs. He urged that there are potential opportunities in niche areas of sports entrepreneurship, fashion entrepreneurship, and rail entrepreneurship.
- 9. Prof. Hulas Pathak emphasized the basic and allied sciences research in the university can be pulled as a technological database for the convergence with the applied innovation that can take place in various sectors, e.g. in agriculture. He suggested taking the lead in creating an internal pipeline of students for idea generation through events like ideathon, hackathon, etc. These students will be future-ready entrepreneurs with their innovative ideas for solutions to the problems society is facing at large. He pledged his support to the IIC PRSU and the university with his experience and wisdom in the field of incubation.
- 10. Dr. Amit Dubey shared that DST, the Government of India is formulating an STI ecosystem. STI ecosystem includes Idea generations from a multi-disciplinary approach which should be practical and implementable for the societal benefits. He suggested linking academia with the industry so that inputs can be sought from the industry. He also suggested the exposure of students to industry and market and the formulation of interdisciplinary approaches for idea generation by the students. We should have a mentor pool to guide the students in idea generation and incubation of their ideas. Documentation and preservation of these ideas in the form that can be later upgraded and formulated in the form of projects. He pledged his support for IPR-related matters in the form of patents, copyrights, etc.
- 11. Dr. Amber Vyas updated the council that the section-8 company establishment is under process and very soon it will be established. He also informed the council that opportunities are being explored for getting financial assistance to the section-8 company from various government agencies.
- 12. Prof. Kavita Thakur acknowledged the presence of numerous ideas and expressed sincere appreciation to all the attendees, assuring that every idea had been duly recorded. She concluded by emphasizing the commitment to enhance the IIC's impact and effectiveness.
- 13. Dr. Laxmi Kant proposed the vote of thanks to all the participants in the meeting for their valuable time and insightful ideas.
