



  - VII. Support from other agencies, if any.
  - VIII. Original receipt of Registration fee payment.
  - IX. Dollar to Rupee conversion certificate from approved agency or S.B.I.
  - 03. The Support is not for expenses other than mentioned above.





Minutes of the General Body (GB) Meeting held on 03 June, 2016 at the Department of Studies in Zoology, University of Mysore, Mysore (Pages 4-3)

#### Business Transacted:

The chairman welcomed members and asked the Secretary to initiate the business proceedings.

All decisions were taken unanimously.

- Minutes of the General Body (GB) meeting held on 28.03.2015 at the Department of Biosciences. (School of Life Science), Pt. Ravishankar Shukla University, Raipur, were confirmed.
- Minutes of the Executive Committee (EC) meeting held on 20.03.2016 at the Department of Biosciences (School of Life Science) were approved and confirmed.
- The Secretary apprised members about the activities of the Society since the last GB meeting was held in March 2015 and the last EC meeting in March 2016. The members applicated the efforts made by the Society during the year,
- The GB approved all administrative and financial decisions and expenditures taken by the Secretary/ Treasurer for the disbursment of funds from the Society account during the financial years 2014-2015 and 2015-2016, and till date (03 June, 2016) in the current financial year (2016-2017), including the Expenditure commitments as per the decisions taken in the EC meeting on 20 March 2016 towards the organization of the workshop/ symposium in conjunction with the Indol'S workshop/symposium during 21-24 February 2017, by the Department of Zoology, University of Delhi, with Prof. Vinod Kumai as the Director/ Convener Prof. Vinod Kumar was authorised to take decisions for the disbursement of funds from the Society (InSe) account as committed vide EC meeting of 20 March 2016 and also as and when necessary for all the expenditures which can meur during the proposed workshop/ conference in February 2017, for which no further approval would

The audited statement of account for the years ending on 31 March 2015 and 31 March 2016, and

- The members applauded the efforts of the Treasurer in getting the PAN for the society, and also getting filed the income tax returns for the financial years 2014-2015 and 2015-2016.
- It was resolved to carryout minor modification in bye-laws vid para 16, which will be read as follows. "All cheques for the cheque amount exceeding Rs, 10,000 shall be signed by two of the three office bearers, the President, Secretary and Treasurer. Thus, for a cheque amount of Rs. 10,001 and higher, the cheque must be signed either by the President and Treasurer, or by the Secretary and Treasurer. However, a cheque for the amount up to Rs. 10,000/-, the Treasurer alone can sign the cheque, if the payment of such an amount has been approved by the President and/ or GB of the InSC." This modification will come into effect from 01 April, 2017, and the Secretary would communicate the State Bank of India. Delhi University Branch, the banker of the InSC, with signatures of the three office beares (President, Secretary and Treasurer) that will take charge of the Society affairs from 01 April 2017, of this modification before the end of the FY 2016-17.
- The following members were unanimously elected by the GB to the office of the InSC till 31 March of the year mentioned against their names. The election of these office bearers will be effective from 01 April 2017.
