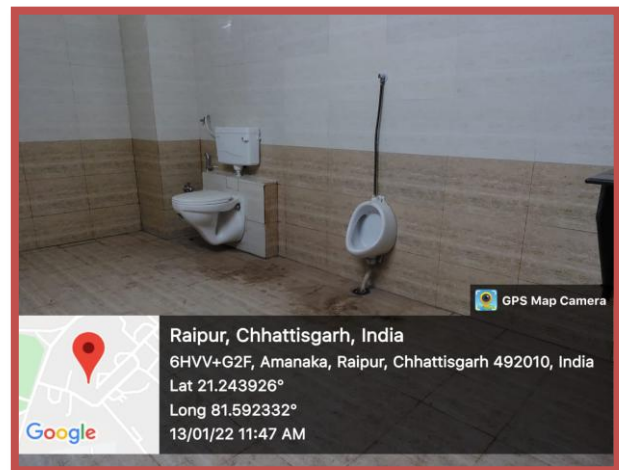
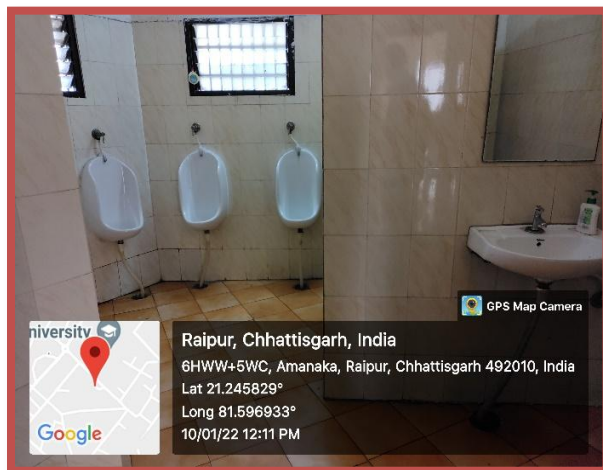
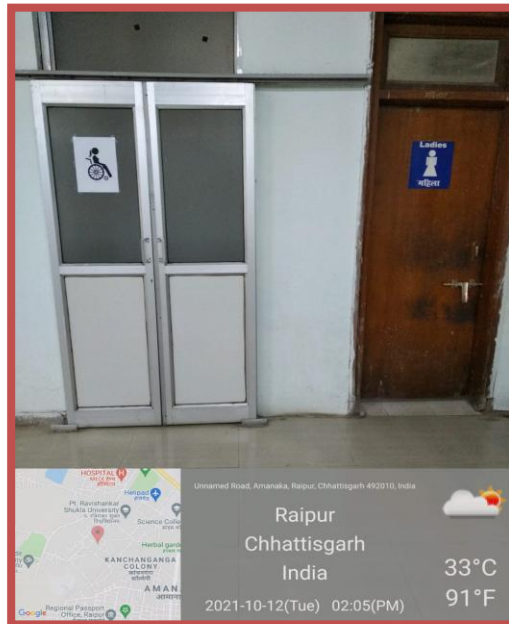
A. Ramp Facility for Divyangjans in various locations at institution:



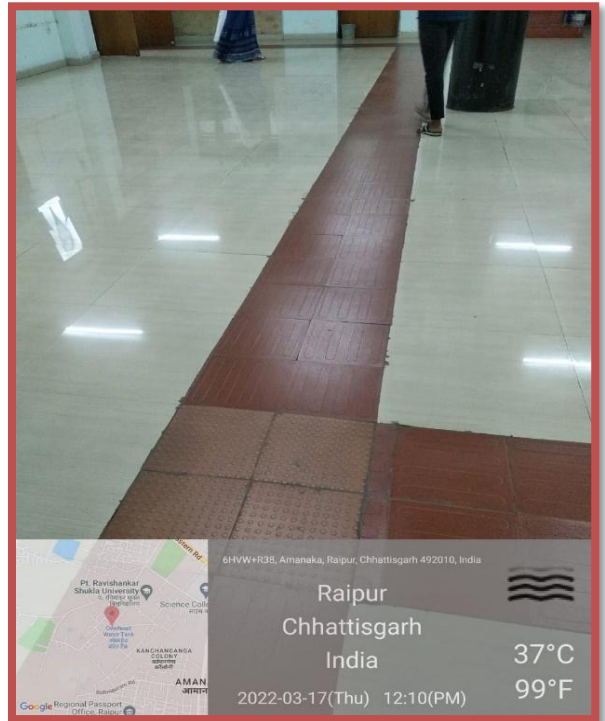
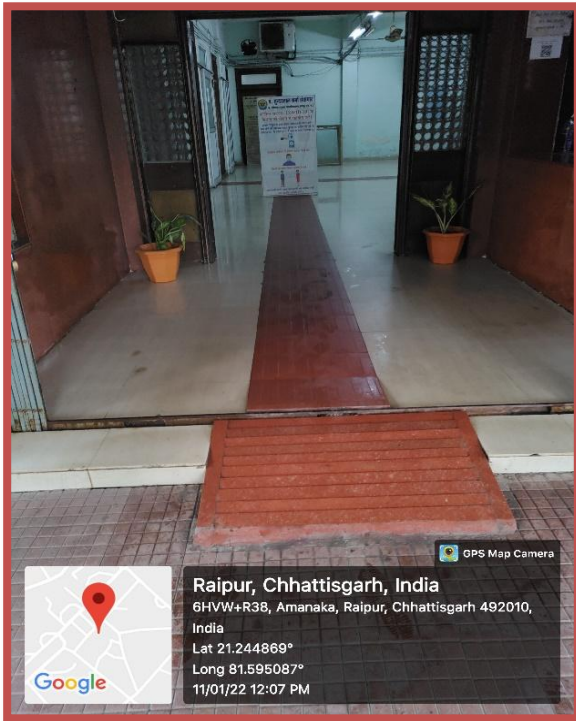
B. Lift Facility for Divyangjans in the institution:
