Subject: - Raman Fellowship for Post Doctoral Research in USA for the Year 2015-16 to be awarded by University Grants Commission.

Sir/Madam.

With reference to your application on the subject cited above, I am pleased to inform you that the UGC has awarded you Raman Fellowship for Post-Doctoral Research in USA for a period of <u>9 Months</u>.

The candidate selected for the award of this fellowship should join the fellowship host institution in USA within six month period from the date of award announcement.

Rules governing payment of salary, Study leave, medical, gratuity, GPF and Pension etc. of the organization / institution / university to which the fellow belongs would continue to be applicable. No liability on any of these accounts will be borne by UGC. However, UGC letter No. 1-6/2012(PS) dated 7<sup>th</sup> June, 2013 (copy enclosed) may be referred to regarding the grant of study leave to university and college teachers.

#### The terms and conditions governing the fellowship are as follows:-

- > The fellow will be entitled to fellowship amount of US \$ 3000 per month.
- The fellow will also be entitled to one time personal contingency grant of up to a maximum amount of Rs. 50,000 to cover for visa, airport transfer, medical insurance etc.
- Fellow will also be permitted to travel within USA to attend conferences or other institutes of interest with the approval of the advisor of the host institute. The fellow will be provided grants for this purpose as per the following:
  - 1. Grant of \$ 600 for fellowship period up to 6 months.
  - II. Grant of \$ 1200 for fellowship period beyond 6 months.

Air-tickets for the selected fellow would be purchased by the respective university/institution by economy class for shortest route directly from Air India from their place of work in India to the place of the American host institute and back. The actual ticket amount would be reimbursed by UGC to the institution for the same on submission of the following documents duly certified by the competent authority of the institution:

- · Visit Report (pro-forma enclosed).
- Utilization Certificate and Item-wise Statement of Expenditure (pro-forma enclosed).
- · Fellowship Completion Certificate from the US Host Institute.
- Original Air Tickets and Boarding Passes.
- Receipts of Visa fee, SEVIS fee & Insurance charges.

The scholar should submit the above mentioned documents as per the prescribed proforma within 45 days after the completion of his/her research work in USA.

In case the fellow leaves the host institution or fellowship without completing the research work, he/she shall be liable for refund of entire fellowship amount within a period of 02 months, failing which it will be treated as misconduct on the part of the fellow, and the Commission shall recommend to the parent institution in India for recovery of award amount and initiation of suitable departmental action against the erring fellow.

If the above -mentioned terms and conditions are acceptable, you are requested to convey your acceptance for availing the fellowship as well as your tentative / final tour program by 15<sup>th</sup> April, 2016. However, one shall have to submit the final tour program before leaving India to pursue the research work at USA. You are also requested to submit the duly filled mandate form (account details of your university/college) along with the acceptance letter (a blank copy of mandate form enclosed).

## Senior Associate of the Centre from 1 January 2012 until 31 December 2017.

This award is, however, subject to the availability of funds each year. Please refer to the Annex to this letter for details.

Senior Associates have at their disposal the sum of Euro 8,000 (this amount may be modestly increased in the near future) to be spent over the above six-year period. These funds can be made available in the form of a daily allowance (which we expect to substantially increase over the next three years) and/or travel expenses in connection with Associate visits. We hope, however, that your travel expenses can be covered by other sources. You may, of course, visit at a time of your own choosing, though it may be more useful to plan these visits when scientific activities in your area of research are being held. The duration of each visit should not exceed 70 days.

In the spirit of making your Associateship appointment as profitable and flexible as possible, you may request your Associateship funds to cover external visits to Institutes which have a Partnership Agreement with the Centre. Requests for these visits must be made through the Associate Scheme Office. The concurrence of both the Associate Scheme Office and the Partner Institute is essential before such visits can be made. Rules governing external visits to Partner Institutes are also given in the Annex.

The enclosed Form A should be sent to the Associate Scheme Office by 30 November of the year preceding the proposed visit. The same procedure applies to requests for visits to Partner Institutes. All requests will be considered taking into account the financial availability at the time.

As you are aware, the Inter-University Centre for Astronomy and Astrophysics (IUCAA) has been set up by the University Grants Commission (UGC) to promote and nucleate astronomy and astrophysics in the universities and affiliated colleges. To this end, IUCAA has launched a number of programmes on its campus at Pune and also on the campuses of various universities and colleges. In particular, arrangements have been made to facilitate the usage by interested students and faculty of universities and colleges of centralized facilities at Pune, such as an advanced Computer Centre with High Performance Computing facility, a state-of-the-art library, the Instrumentation Laboratory and observational facilities including the South African Large Telescope (SALT) at Sutherland. IUCAA is also involved in a number of large projects of national and international importance like ASTROSAT, LIGO-India, the Thirty Metre Telescope, etc.

One major activity in this context is the Associateship Programme. Under this programme, faculty members of universities and colleges, who are made Visiting Associates of IUCAA, can make visits to IUCAA for specified periods to participate in the teaching research and development activities in astronomy and astrophysics. For such purposes, the universities and colleges are encouraged to regard IUCAA as their field station, whose facilities are at their disposal. Indeed, Professor Arun Nigavekar, the then Chairman of the UGC, has written in 2004 to all the University Vice-Chancellors urging them to look upon IUCAA in this spirit and to make it possible for the Visiting Associates to use its facilities to the maximum extent possible. I enclose for your ready reference a copy of this letter from the Chairman.

As part of the Associateship Programme, IUCAA has selected 17 new Visiting Associates this year and has extended the term of 53 Visiting Associates for a further period of three years. I am happy to inform you that the term of Dr. Laxmikant Chaware from your University has been further extended for three years from August 1, 2021. Under the Associateship Programme, IUCAA will pay the travel and per diem of the Visiting Associates coming to IUCAA for their scientific work.

I do hope that you will encourage Dr. Chaware to take advantage of this offer. I request you to treat Dr. Chaware 's stay at IUCAA as a part of his duties and to provide him with leave as "on duty" so that he can make good use of his Associateship. I enclose the Terms and Conditions of the Associateship Programme for your information.

The University Grants Commission has set up a number of Inter-University Centres and Consortia in order to provide front line research and developmental facilities to the staff and students from universities and colleges in selected thrust areas. It is extremely important, therefore, that the prospective users of the Inter-University Centres are freely permitted to participate in their various programmes as if they are "on duty". In some universities, it is noted that the scholars' visits were not considered as on duty.

Amongst such Centres, the Inter-University Centre for Astronomy and Astrophysics (IUCAA) has an Associateship programme under which selected Associates from universities and colleges are invited to visit IUCAA as Associates of the Centre. Each Associate has a tenure of three years, which can be renewed depending on his/her performance, in teaching, research and developmental activities. It is understood that during these three years, the Associate visits IUCAA several times for visits of at least two weeks duration at a time, without compromising with his/her lecturing and other duties in the parent institution. Their visits are fully covered by IUCAA and hence has no financial implication to the university/college.

IUCAA has a number of facilities like an excellent Library, state of the art Computer Centre, Virtual Observatory as well as an Instrumentation Laboratory where the university staff members can make their own instruments as well as participate in collaborative instrumentation projects. As of now, IUCAA has over eighty Associates on its roll. In order to improve their efficiency, it is important that they are permitted to take advantage of these facilities as much as possible.

I, therefore, urge you to facilitate the participation of Associates from your Institution in the above programme by treating their leave of absence as on duty when they visit IUCAA, which is specifically created by the University Grants Commission as a common facility for all universities.

## TERMS AND CONDITIONS OF IUCAA'S ASSOCIATESHIP PROGRAMME

- Visiting Associateship is awarded to a faculty member of a college, university department or institution, which has the status
  of a university recognized by the UGC.
- Visiting Associateship is awarded for a period of three years at a time. If a Visiting Associate ceases to have a formal link
  with a college or university during the period of an Associateship, then the Associateship stands terminated. Information
  regarding such a change should be conveyed to the Dean, Visitor Academic Programmes.
- A Visiting Associate can visit IUCAA a maximum of three times as an Associate during each academic year, which extends from August 1 to July 31. There has to be at least one visit during each academic year.
- A visit under the Visiting Associateship programme has to be preferably at least of 15 days duration. A maximum of 150 days can be spent at IUCAA during any one academic year.
- During the three year period of a Visiting Associateship, there can be a maximum of six visits, totally to a maximum of 365 days.
- Travel: It is expected that journeys will generally be by air or rail or road by the direct shortest route. All Visiting Associates
  are entitled to travel by train AC-II tier. Travel reimbursement will only be to the extent of the actual class of travel upto ACII tier. The claimant will have to produce to and fro tickets/copies of tickets.

Limited funds are available for air travel of Visiting Associates. Air travel may be permitted subject to the following conditions:

- (a) Grade Pay of the claimant is at least Rs. 5400/- (Level: 09) or equivalent per month.
- (b) The claimant stays at IUCAA for a minimum of 15 days.
- (c) Air travel should be by Air India flights only as per GOI rules. Tickets & Boarding Pass to be enclosed along with the claim.

Even when these conditions are satisfied, **prior approval from the Dean, Visitor Academic Programmes** will have to be obtained. Air travel over special sectors, especially in the North-Eastern parts of the country, may be permitted even when the conditions (a) and (b) are not met. Details about this may be had from the Administrative Officer (Visitor Services). The air travel will have to be by the shortest direct route. Those who are not eligible for air travel can choose to travel by air with the understanding that they will be reimbursed only to the extent of eligible train fare or actual air fare, whichever is lower.

- Daily Allowance (DA): Visiting Associates are paid DA @ Rs. 600/- per day with free lodging. Charges for Canteen, Cable
  TV and cooking gas, wherever applicable, will be recovered.
- Acknowledgement: Visiting Associates should not give IUCAA as their affiliation. But those who use the IUCAA facilities
  for research work leading to publications should acknowledge IUCAA in their publication.
- Accommodation: We try to ensure that Visiting Associates are accommodated whenever they wish to visit IUCAA. However, there is very high demand during vacations, when most visitors like to come to IUCAA. All intending visitors are, therefore, urged to write to us about their plans for a stay at IUCAA at least two months in advance. This is particularly necessary for family accommodation, since the number of units, which can accommodate families is very limited. Please write to us well in advance with alternative dates and await confirmation from us. You will be guaranteed accommodation on arrival at IUCAA only if you have a word of confirmation sent by us.
- Visit by research students of Visiting Associates: The students should write to the Dean, Visitor Academic Programmes, along with a copy of their bio-data, proposed plan of work at IUCAA, and a recommendation by the concerned Visiting Associate.

At a given time, only one student of a Visiting Associate can visit IUCAA. It is not essential for the guide/the concerned Visiting Associate to be present at the time of a student's visit, except for students who are visiting for the first time.

The DA entitlement for research students (registered for M. Phil/Ph.D.) is Rs. 300/- per day with free lodging, and canteen will be charged. They are entitled to travel by train by AC Chair Car or AC -III tier by the direct shortest route. Travel by AC-II tier will be permitted only if the trains on the shortest route do not have any of the above classes. The tickets/copies of the tickets will have to be submitted with the claim. However, the following provisions apply:

Research Students with fellowship: Students with fellowship will have to pay for travel from their contingency grant. When such a grant is not available, they should write in advance to the Dean, Visitor Academic Programmes for travel reimbursement.

Research Students without fellowship: They will be paid for their travel and DA (with free lodging; canteen will be charged), for the full period of their stay. The guide of such students will have to submit a letter to the effect that the students do not have fellowship.

At the end of the visit, all students are required to submit a report to the Dean, Visitor Academic Programmes about the work done at IUCAA.

This is with reference to your application (Ref. ID. 2019-00384) submitted to the ICMR for Long Term ICMR-DHR International Fellowship for Young Bio-medical Scientists.

I am directed to inform you that the Selection Committee of the Council has selected you for the above fellowship for a period of six months.

The terms and conditions for the fellowship are as under:

- 1. You will be provided a monthly stipend of US\$ 3000 per month for the above period and contingency of Rs.50,000/-. The expenses on visa charges, overseas mediclaim insurance and taxi fare from the place of duty to airport & back will be reimbursed as per actual on production of original receipts under the contingency grant. No other charges/expenses are admissible.
- 2. You will be entitled to travel by air (both ways) by Air India in economy class (excursion fare) by the shortest route from the place of duty.
- 3. The advance fellowship amount will be released on receipt of a copy of visa. All necessary formalities to obtain visa should be taken care of by the Fellow.
- 4. Total claim bills on the budget head of fellowship should not exceed the fellowship amount specified above.

- The Fellow is required to intimate to this office the exact date of travel. Any penalty or cancellation charges due to change of date are to be borne by the Fellow.
- 6. You will not be allowed to change the foreign mentor and place of laboratory.
- 7. You should get the overseas mediclaim insurance covered before leaving the country.
- 8. Parent Institute shall continue to pay salary and other benefits such as leave, medical gratuity. GPF, pension as applicable to you during your fellowship period. However it should be governed according to the rules of parent Institute. No liability on any of these accounts will be borne by ICMR. You will not draw any salary/stipend outside India, while on ICMR-DHR fellowship.
- You are required to submit progress/work report (in the prescribed format) within 2 weeks
  after your return on the research and training activities undertaken in the foreign
  laboratory/Institute during the fellowship period.
- 10. You are required to execute a service/legal bond for Rs.5.00 lacs to the parent Institute that you belong to, for serving the parent Indian Institute for a period of at least 3 years after return from overseas fellowship. A copy of bond should be submitted to ICMR (if not already submitted).
- 11. If you do not return to India or get a job overseas on completion of the fellowship or fail to fulfill any of the above requirements, you will be liable to reimburse the whole of the expenditure incurred during the fellowship period, including the airfare, from the Guarantees in one lump- sum within one month of the completion of the term of the Fellowship and remit it to ICMR.
- 12. In case, due to some reasons, the Fellow returns to India before completion of committed duration of training, the balance amount of fellowship grant will be required to be reimbursed to ICMR within 15 days of return to India.
- An undertaking to cover issues mentioned against points 11 & 12 above by two Guarantees on Rs.50/-non-judicial stamp paper are required to be submitted to ICMR.
- 14. The training should be initiated before 31<sup>st</sup> March, 2020. No extension of date to avail fellowship will be granted beyond 31<sup>st</sup> March, 2020. However, the ICMR will require at least 2 months advance notice for obtaining Political clearances & booking of air tickets etc.
- 15. You are expected to implement and establish training acquired and utilize the expertise into the ongoing/future programmes of your parent Indian Institute after availing the ICMR-DHR International fellowship. The publications, research grants, projects developed and infrastructure/capacity strengthening of your parent Institute shall be reported upon to ICMR during the consequent years of availing the fellowship since it is the basic objective of this Fellowship programme.
- 16. It may please be noted that the refusal by a Fellow to undertake the ICMR International Fellowship award for a given year will de-bar him/her to avail the fellowship for the succeeding two years.




