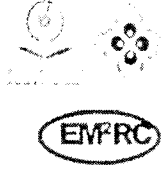

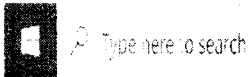

School of Studies in Psychology : Identified by MHRD, New Delhi as a National Resource Centre (NRC) ✓

The ministry of Human Resource Development has launched a major and unique initiative of online professional development of higher education faculty using the Massive Open Online Courses (MOOCs) platform SWAYAM. In the first phase (2018-19) 75 disciplines specific National Resource Centers(NRCs) were identified, Psychology was one of them given to Pt. Ravishankar Shukla University, Raipur. The proposal for the same was sent by HRDC, Pt.RSU,Raipur. Our task was to prepare online training material with focus on latest developments in the discipline, new emerging trends, pedagogical improvements and methodologies for transacting the curriculum .

Under this initiative, all in service teachers had an enabling opportunity to keep abreast of the latest developments in their disciplines, through the technology based online refresher course.

To created a course content Academic Advisory Council was formed with members from host institution and five members from other institutions. A meeting of inhouse members was held in the Hon'ble Vice Chancellor's office on 8th May, 2018 and Prof. Promila Singh was given a charge of the course coordinator. The course coordinator identified the resource persons who were wiling to contribute in the creation of course content and also in the identification of components to be included in the course.

First meeting of all Academic Advisory Council members was hled on 6th Aug., 2018 in the Hon'ble Vice Chancellor's chamber to finalize the course

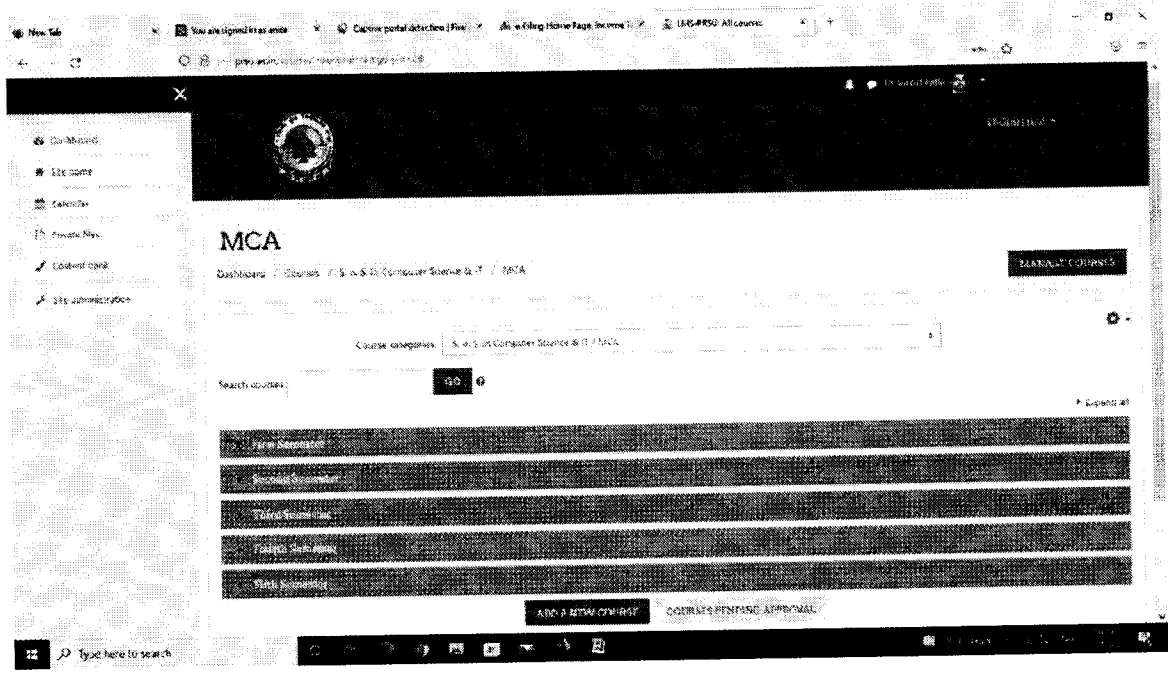
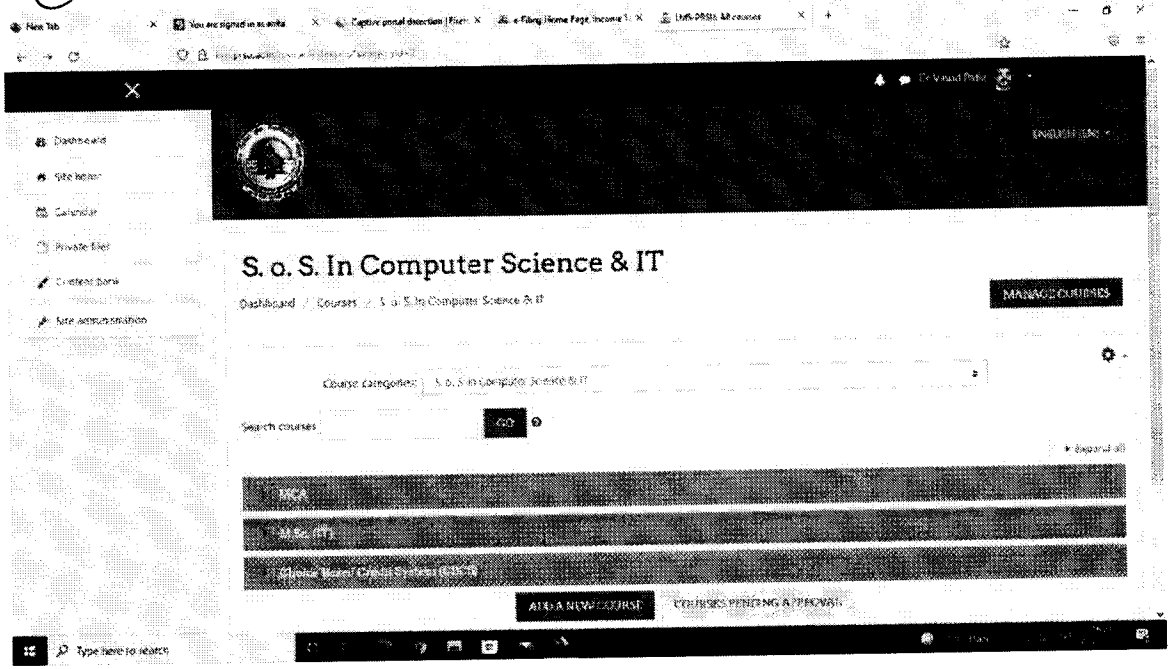
content. It was decided to develop 40 hours course content , with 20 hours of video content and 20 hours of e-content, based of four quadrant approach, The course had a component of discussion forum and assessment also.


The three minute introductory video covering content, methodology and outcome was sent for approval to MHRD, once approved it was uploaded and the course was announced . The faculty were requested for online registration. The course was formally launched by MHRD online as ARPIT on 13th Nov., 2018.

Monthly review meetings by Secretary (HE) MHRD on matters related to course, finances and progress were conducted via video conferencing mode. UGC wrote to all universities to inform faculty to register for the online refresher course. After the completion of the course online examination was conducted by the NTA on 30th March, 2019 and certificates were issued to the faculty members who qualified the exam.
