MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on Saturday 14 July, 2023, Between Pt. Ravishankar Shukla University, Raipur (C.G.) hereinafter referred to as PRSU, which unless repugnant to the context would include their successors, assigners, agents and executor on one part, hereinafter, referred to as which unless repugnant to the context shall include their successors, assigners, agents and executors on the other part as the First Party.

Pt. Ravishankar Shukla University, Raipur is an Academic and Research Institution. The vision of the University is to make quality higher Education accessible to all sections of society, including the Tribal population of Chhattisgarh to provide quality education in the disciplines of arts, humanities, social sciences, natural sciences and others disciplines of learning, and to develop human resource with world class competence and skills in the respective disciplines. The vision will enable to steadily carry forward the mission of developing the

university as centre of excellence for higher education and knowledge, to promote understanding the value of self learning, creativity and competence building.

Ayodhya Research Institute, Department of Culture, Government of Uttar Pradesh, Lucknow, hereinafter, referred to as ARI which unless repugnant to the context shall include their successors, assigners, agents and executors on the other part.

ARI is an academic and cultural institution in Uttar Pradesh. It is an autonomous institute under the Department of Culture, Government of Uttar Pradesh, Lucknow and having its registered office at Tulsi Smarak Bhavan, Raiganj, Ayodhya, Uttar Pradesh (India) and a camp office in Lucknow which expression shall, unless repugnant to the context or meaning thereof, to be deemed to mean and include its administrators, successors, executors and assigners, as the **Second Party**.

Both the institutes are hereinafter referred as "Parties".

1. INTENT OF WORK:

Through this Memorandum of Understanding, based on the principles of equality, reciprocity and mutual benefits, PRSU and ARI hereby agree to explore the following avenues of educational and cultural exchanges:

1. To promote and preserve the Ramayana and Ramkatha Traditions across the Globe.
2. To facilitate the research work on Indian Culture especially on Ramayana and Ramkatha Traditions.
3. To provide available research facilities with the parties to the researchers, art connoisseurs and academicians etc.
4. To strengthen inter-cultural relations between both the parties.
5. To invite the cultural groups on several cultural occasions in which boarding & lodging, light, sound, stage, publicity and other local hospitality will be borne by the hosting institute and honorarium with their travel expenses of the troupes will be borne by the responding party.
6. Logo of both parties will be displayed in each publicity material.
7. The sharing of resources and knowledge by the research scholars.
8. Working jointly on various research projects.
9. Translation of the Sanskrit texts based on Ramkatha and Ramayana Tradition.
10. Organising lectures by inviting reputed faculties of each other.
11. Work on the preservation and publication of the original ancient manuscripts.


5. DISPUTE RESOLUTION:


6. MID COURSE REVIEW:

Activities under the MoU may be renewed in the end of the financial year of its implementation to consider if any by the activity are to be expanded or discontinued.


In principle, both the institutions are agreed upon the terms and conditions laid down in the MoU, subject to the completion of such other formalities required by the relevant rules governing both the institutions.



**Umbrella Memorandum of Understanding
Between
ICAR-National Institute of Biotic Stress Management, Raipur
and
Pt. Ravishanker Shukla University, Raipur
for facilitating
Students Training/ Post Graduate Research/ Doctorate Research**

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this **01** day of the month of **June** in the year **2022** by and between the **ICAR-National Institute of Biotic Stress Management** having its Head Office at **Raipur** [hereinafter called "**NIBSM**"/ First party], a constituent Research Institution of the Indian Council of Agricultural Research, Krishi Bhavan, New Delhi-110 001, on the ONE PART and the **Pt. Ravishanker Shukla University, Raipur** (State University) having its headquarter at **Raipur** [hereinafter called "**PRSU**"/ Second party] on the OTHER PART (who for the purpose of this MoU are herein after collectively referred to as the parties).

The parties, having discussed fields of common research interests and allied activities between the two institutions, have decided to enter into long-term collaboration for promotion of students' training, quality postgraduate research and doctorate research in cutting edge areas in accordance with the provisions contained in the Guidelines issued *vide* Letter No. 2-8/2012-HRD dated 11th December, 2012 or as revised from time to time.

WHEREAS the "First Party" is involved in the studies on **Biotic Stress in Agricultural Crops with major disciplines of Agricultural Biotechnology, Plant Pathology, Agricultural Entomology and Nematology, Weed Science** (specific mandated domain

within the approved disciplines/ divisions), WHEREAS, the "Second Party", established in 1964 following the Act No: 13, of Madhya Pradesh Vidhan Sabha, Bhopal, which was approved in the Parliament on 17 May 1963 as "Ravishankar University Act 1963", and recognized by the University Grants Commission, New Delhi, and is involved in **Teaching and Research in Biotechnology and Life Sciences including Plant Biotechnology, Plant Physiology, Microbiology, Biochemistry, Environmental Science, Mushroom Technology, Bioprocess Engineering, Chemistry, Computer Science, etc.**

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.

Article 1. Scope

- 1.1 The Second party will recognize the First party as an Institute for conducting research related to the thesis requirement of the research students for **M Sc, M Tech and Ph D Degrees in relevant disciplines**. The Second party will recognize Scientists of the ICAR Institute as recommended by its Director in accordance with the University rules and regulations for guiding students working for the said degree.
- 1.2 Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines/ divisions. The objective(s) for research work for a student coming from a Second party outside NARS should be exclusively different as far as possible.
- 1.3 Research instrumentation facility and library facilities available with the First party and the Second party will be made available to the faculty and research scholars. However, the costs of specific consumables will be borne by the respective organizations.
- 1.4 There shall be an exchange of students for academic, research and training purposes. Accommodation in the Hostel shall be arranged, wherever possible, as per extant rates. The duration of exchange visits will be determined by mutual consent between both the parties.

Article 2. Management

- 2.1 Director of the First party and the Vice-Chancellor/ Head of the Institution of the Second party will be responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.
- 2.2 The Advisory Committee will meet at least once in a year alternatively in the institutions of the First party and the Second party to review the activities. This meeting shall include presentation on the academic and research activities, which should be open to the students, faculties and scientists.

Article 3. Exchange of Information

- 3.1. The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MoU.
- 3.2. The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

Article 4. General Provisions

- 4.1 It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.
- 4.2 Both parties understand that all financial agreements will have to be negotiated separately and will depend on the availability of funds.

- 4.3 Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the regulations and policies of the First party and the Second party.
- 4.4 Any research publications arising will be jointly published in accordance with the provisions laid out in Item 3.2.1C of the Guidelines for the students to conduct research for their degree programme as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD, dated 11th December, 2012 or revised guidelines, if any, as may be issued from time to time.
- 4.5 A copy of the thesis/ dissertation will be submitted to the First Party after the award of the degree by the Second party.
- 4.6 All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified for the settlement of dispute, if any.
- 4.7 All questions not foreseen related to this MoU will be handled by the parties by mutual agreement.
- 4.8 Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

Article 5. Intellectual Property Rights

- 5.1 The Second party will be expected to ensure protection of the Intellectual Property Rights generated or likely to be generated during the students research work. The ICAR as the First applicant (for its institute) and the Second party shall be the joint applicants for IPRs and the students and involved scientific staff shall be included as the inventor/ breeder/ author/ researcher. The "ICAR Guidelines for Intellectual Property Management and Technology Transfer/ Commercialization" as amended from time to time shall be the reference for exploitation of the generated intellectual property, whose management and benefits sharing shall be mutually decided in each case.

Article 6. Admission and Fees

- 6.1 All those who wish to register as trainees or for Master/ Doctoral programme under this MoU must apply for admission at the Second party. The allocation of Major Guide/ Advisor would be finalized before the registration and will be governed by the provisions laid out in Items 3.2.1A and 3.2.2A of the Guidelines for the students to conduct research for their degree programmes as trainees at ICAR institutions as notified *vide* Letter No. 2-8/2012-HRD, dated 11th December, 2012 or revised Guidelines, if any, as may be issued from time to time, for the students from within NARS and outside NARS, respectively.
- 6.2 Admission of the students and the award of degrees for different programmes will be the responsibility of the Second party as per the rules and regulations.
- 6.3 Allotment of the students at the First party will be done by the approval of Director of the First party and the Vice-Chancellor/ Head of the Institution of the Second party.
- 6.4 The First party would have the right to screen the students eligibility for admission based on their academic period.
- 6.5 The PME Cell of the First party in consultation with the representative of the Second party shall decide the location and sharing quantum of research work.
- 6.6 The number of student(s) at any particular time will be subjected to the availability of research facilities and scientists time to guide thesis/ research at the First party institution.
- 6.7 Any student(s) admitted to the First party for training/ postgraduate research/ doctorate research, if found violating the rules and regulations lay down by the First party or indulge in such activities that amount to tarnishing the image of the Institute, or cause damage to the property, the registration of such student(s) would be summarily terminated. The Second party will not complete formalities of issuing certificates to such students until they compensate losses to the First party.
- 6.8 Fees will be charged from the students by the First party as per Guidelines for the students to conduct research for their degree programmes as trainees at ICAR institutions *vide* Letter No. 2-8/2012-HRD, dated 11th December, 2012 or revised Guidelines, if any, as may be issued from time to time. No fee may be charged by the First party from the students registered with AU/ DU within NARS. However a student registered with a Second party, outside NARS, will deposit fee of Rs. 10,000.00 for training duration of 3 months (not leading to a degree/ dissertation) and Rs. 30,000.00 per semester (six months) for training/ research/ dissertation exceeding three months.

Any change in fee structure by ICAR will be applicable from the date of revision and shall be charged by the First party.

Article 7. Entry into Effect, Modification and Termination

- 7.1. This MoU shall become effective on the date it is signed by the parties and shall be **valid for three years extendable up to five years**. Both parties shall review the status of the MoU at the end of each three/ five year period to determine any modification, whenever necessary. The period of validity of this MoU may be extended by mutual consent up to five years. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.
- 7.2. All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.
- 7.3. No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/ changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed to.

(This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party).

IN WITNESS WHEREOF, the parties have executed this MoU and represent that they approve, accept and agree to terms contained herein.

WHEREAS,

- i. IBITF, a company limited by Guarantee and incorporated under section 8 of the Companies Act 2013, has been promoted by the Indian Institute of Technology Bhilai ("IIT Bhilai"). The Company is mandated to operate in the FinTech domain, working in thematic areas of e-payment Systems, Blockchain Technologies, Artificial Intelligence, Internet of Things, etc.
- ii. Pandit Ravishankar Shukla University (PRSU) Raipur was established following the Madhya Pradesh Act No: 13 of 1963 and came into existence on 01 May 1964. PRSU has offered high-quality courses in various disciplines, viz., Humanities, Biological sciences, Social Sciences, Natural science, Law, Education, Pharmacy, Economics, Physical science, Management, Physical education, Biotechnology, Library science, Computer science etc. and rewarding experiences for over more than six decades. It has already implemented "Innovation and Start-up Policy" of the MHRD, New Delhi, in the campus and is trying its best to provide state of the art facilities and a conducive ecosystem to innovators and entrepreneurs of various sectors. Moreover, in view to promote innovative and collaborative studies and research projects of various disciplines, it has established an "Institutional Innovation Council" which is functioning proactively and is meticulously planning to shortly establish a Section 8 company in the campus to promote innovations and start-ups.

- iii. This MoU shall also be read along with the Tripartite Agreement dated 29th January 2021 signed among Mission Director, Mission Office NM-ICPS, Ministry of Science & Technology, Department of Science & Technology, Indian Institute of Technology Bhilai and IIT Bhilai Innovation and Technology Foundation for establishing a Technology Innovation Hub (“TIH”) for implementation and realizing the part of objectives of National Mission on Interdisciplinary Cyber-Physical Systems (“NM- ICPS Mission” or “Mission”)
- iv. The **Institute** assumes to undertake the financial and other management responsibilities for implementing the R&D activities and Technology Development Programme of the “Mission” until the project is operational. It shall be responsible to the IBITF under General Financial Rules (GFR-2017) for all accounting purposes.
- v. The PI works for an R&D Project (“R&D Work”) under the Mission. The brief details of the R&D Work are appended in Annexure-1 to this MoU.

NOW, THEREFORE, IN PURSUANCE OF THE AFOREMENTIONED, **IBITF, the PI, and the INSTITUTE** HEREBY AGREE TO ENTER INTO THIS MOU AS PER THE TERMS AND CONDITIONS STATED AND APPEARING HEREINAFTER:

1. Objectives–

- a) This MoU is designed and intended to state that the Parties wish to cooperate in FinTech and research, and each Party’s contribution is according to the arrangement and as per the general terms laid down in this MoU. The Parties also wish to develop & foster collaboration for addressing the current and future FinTech challenges in different sectors.
- b) The **Institute** should provide a congenial atmosphere and access to all common infrastructural facilities to the PI, including equipment, computational facility, library, acceptable laboratory, and office space during the tenure of the MoU.
- c) The **PI and the Institute** shall be required to submit Half Yearly and Annually Project Progress Reports, Utilization Certificates (UCs), and Financial Statements to IBITF to consider releasing the next installments accordingly

1. Confidential Information

- a. "Confidential Information" means and includes all research, models, formulae, assays, programs, algorithms, processes, techniques, Project specific information, trade secrets or other information of any kind, including, without limitation, proprietary information (whether or not patentable) regarding a Party's Background IP or Foreground IP, or its technology, products, business, customers, employees, strategies or objectives, which is confidential to such Party, whether or not expressly designated as such, and whether disclosed prior or after the date of this MoU. It shall also include all technical, corporate, financial, economic, legal, or other information or knowledge generally concerning the Party, whether disclosed orally or in the form of written material, computer data, or programs, during or preparatory to the Project identified in writing at the time of disclosure by an appropriate legend, marking, stamp



or other positive written identification on the face of the document or item, or if oral, which is confirmed as confidential by writing submitted by the Party claiming confidentiality to the other Party within twenty (20) days of the disclosure.

- b. In the performance of the Research, it may be necessary for one Party to receive information that is proprietary and confidential to the Disclosing Party. All such information disclosed by the Disclosing Party orally or in any tangible form shall be considered Confidential Information and kept in strict confidence. Except as otherwise provided herein, for a period of three (3) years following the date of expiration or termination of this MoU, the Receiving Party agrees to use the confidential information only for purposes of this MoU and further agrees that it will not disclose or publish such information without the prior written consent of the Disclosing Party.
- c. **Exceptions to the Confidential Information-** This MoU does not apply to Confidential information that:
- i. is in the public domain at the time of disclosure or later becomes part of the public domain through no fault of the Receiving Party; or
 - ii. Was known to the Receiving Party at the time of disclosure or was independently developed by the Receiving Party, provided there is adequate documentation to confirm such prior knowledge or independent development.
 - iii. is disclosed to the Receiving Party by a third party, and the Receiving Party was not aware that the third party had a duty of confidentiality to Disclosing Party in respect of the information;
 - iv. is used or disclosed by the Receiving Party with Disclosing Party's prior written approval; or
 - v. is required to be disclosed by law or directions from a Court of Law or Government/Government Authorities, provided that Receiving Party makes its best effort to give Disclosing Party prior notice and the opportunity to obtain an order to prevent or restrict any such disclosure.
- d. The Receiving Party must prevent its employees' inadvertent, accidental, unauthorized, or mistaken disclosure or use of the Confidential Information disclosed hereunder.
- e. Neither Party shall disclose Research Results or neither any aspect of the existence



nor the technical progress of the Project to the public or any thirdparty, except with the other Party's prior consent.

2. Term & Termination--

9. **Publications** – The Institute and its employees shall have the right, at their discretion, to release information or to publish and disseminate any Research Results, including, but not limited to, data, writings, or material resulting from the Project. The Institute shall furnish the Company thirty (30) days from the date of furnishing for review and comment to ascertain whether the publication would disclose Sponsor's Confidential Information or to allow IP protection. - 14) Sustainable Development Goals (SDG);

और

पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर संस्था के रूप (Training Provider Institute, TPI के रूप में संदर्भित) में पंजीकृत है, जिसका कार्यालय आमनाका, जिला - रायपुर (492010) के बीच में अनुबंध निम्नानुसार होंगे :-

अतएव -

1. कौशल विकास, तकनीकी शिक्षा, रोजगार विभाग अंतर्गत छत्तीसगढ़ राज्य कौशल विकास प्राधिकरण (CSSDA) राज्य स्तर पर लघु अवधि के कौशल प्रशिक्षण एवं प्रशिक्षण पश्चात रोजगार सेवाओं से संबंधित योजनाओं / कार्यक्रमों के क्रियान्वयन एवं समन्वय हेतु शीर्ष संस्था है।
2. पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर में स्थित, उपलब्ध संसाधनों का उपयोग कर शिक्षित युवाओं को आधुनिक प्रौद्योगिकी में कुशल कर रोजगार एवं स्वरोजगार के योग्य बनाने के उद्देश्य से संस्था द्वारा अनुबंध/ समझौता ज्ञापन के तहत Training Provider Institute (TPI) के रूप में कौशल विकास गतिविधियों का संचालन करने के लिए CSSDA के साथ अनुबंध (MoU) करने आवेदन किया गया है।
3. यह अनुबंध संस्था को एक Training Provider Institute (TPI) के रूप में पंजीयन कर छत्तीसगढ़ राज्य के युवाओं को आधुनिक प्रौद्योगिकी आधारित कौशल प्रशिक्षण प्रदान करने तैयार किया गया है, जहां संस्था के पास प्रशिक्षण हेतु पहले से ही स्थापित आधारभूत अधोसंरचना, गुणवत्तायुक्त प्रशिक्षण सुविधाएं और साथ ही प्रशिक्षित प्रशिक्षक उपलब्ध होते हैं, जो शिक्षित युवाओं को संस्था परिसर में ही कौशल प्रशिक्षण प्रदान कर सकेंगे।
4. अनुबंध/ समझौता ज्ञापन (MoU) कौशल विकास योजना के तहत संस्थान एवं प्रशिक्षणार्थियों की आवश्यकताओं को पूरा करने के लिए किया जा रहा है, जिसमें संस्थान में उपलब्ध संसाधन का उपयोग, आधुनिक प्रौद्योगिकी में आवश्यक कुशल मानव संसाधन की कार्य प्रकृति के अनुरूप NSQF आधारित कोर्स में युवाओं को TPI द्वारा प्रशिक्षण प्रदान किया जाता होगा।
5. यह अनुबंध TPI के रूप में पंजीकृत संस्थान को अपने परिसर में युवाओं को प्रशिक्षण हेतु एकत्रित करने, क्लास रूम एवं प्रायोगिक प्रशिक्षण प्रदान करने एवं सॉफ्ट-स्किल / कैरियर परामर्श पर सत्र आयोजित करने की स्वीकृति प्रदान करता है।
6. इस अनुबंध के तहत अनुभवी विशेषज्ञों/ पेशेवरों के द्वारा नवीनतम मशीनों, औजार और उपकरणों के साथ नवीन तकनीक के माध्यम से प्रशिक्षण कार्य कराया जा सकेगा।
7. राज्य के युवाओं को आधुनिक प्रौद्योगिकी आधारित कुशल कार्यबल में बदलने के लिए CSSDA प्रतिबद्ध है। युवाओं को आधुनिक प्रौद्योगिकी में कुशल करने, रोजगार एवं स्वरोजगार के योग्य बनाने कौशल प्रशिक्षण का संचालन करने हेतु छत्तीसगढ़ राज्य कौशल विकास प्राधिकरण (CSSDA), कौशल विकास, तकनीकी शिक्षा, रोजगार एवं प्रशिक्षण विभाग एवं पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर इस अनुबंध / समझौता ज्ञापन पर हस्ताक्षर करने के लिए पारस्परिक रूप से सहमत हैं।

I. उद्देश्य-

CSSDA और TPI निम्नलिखित उद्देश्यों के साथ इस समझौता ज्ञापन में शामिल होने के लिए पारस्परिक रूप से सहमत हुए हैं:

1. संस्था एवं प्रशिक्षणार्थियों की आवश्यकताओं को पूरा करना।

2. वर्तमान परिदृश्य में आधुनिक प्रौद्योगिकी में आवश्यक कौशल के अनुरूप NSQF कोर्स में नवीनतम तकनीक के माध्यम से संस्था परिसर में ही युवाओं का प्रशिक्षण ।
3. संस्था द्वारा प्रशिक्षण हेतु युवाओं का चयन एवं व्यावहारिक आकलन कर प्रशिक्षण देना एवं रोजगार/स्वरोजगार योग्य बनाना ।
4. कुशल जनशक्ति तैयार कर देश के समग्र विकास में योगदान देना ।

II. CSSDA की भूमिका

- 1) कौशल प्रशिक्षण हेतु CSSDA द्वारा संस्था से किये गए अनुबंध/ समझौता ज्ञापन के बारे में छत्तीसगढ़ राज्य के युवाओं को जागरूक करना ।
- 2) CSSDA पोर्टल पर Training Provider Institute (TPI) के साथ हस्ताक्षरित अनुबंध / समझौता ज्ञापन का विवरण प्रकाशित करना ।
- 3) संस्थानों से TPI के रूप में आवेदन आमंत्रित करना तथा योजना के दिशा-निर्देशों के तहत निर्धारित प्रक्रिया के अनुसार TPI से प्राप्त आवेदन की जांच करना ।
- 4) TPI के रूप में पंजीकृत पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर द्वारा आवेदित कोर्स / पाठ्यक्रम और प्रशिक्षण हेतु आवश्यक अधोसंरचना, लैब, औजार उपकरण इत्यादि की मूल्यांकन करना ।
- 5) आवेदन पर स्वीकृति उपरांत संस्था से TPI के रूप में समझौता ज्ञापन पर हस्ताक्षर करना ।
- 6) CSSDA पोर्टल पर समझौता ज्ञापन की एक प्रति अपलोड करना ।
- 7) TPI के पंजीकरण, प्रशिक्षणार्थियों का विवरण अपलोड करने, मूल्यांकन कार्य के लिए पंजीकरण, प्रवेश पत्र जारी करने, प्रारंभिक मूल्यांकन अंक अपलोड करने, अंक पत्र बनाने और प्रमाणपत्र जारी करने के लिए CSSDA पोर्टल पर प्रावधान बनाना ।
- 8) TPI, प्रशिक्षणार्थियों, मूल्यांकनकर्ता एवं अन्य हितधारकों को कौशल प्रशिक्षण से सम्बंधित जानकारी प्राप्त करने, संदेश साझा करने एवं अपनी जानकारी देने हेतु CSSDA पोर्टल पर सुविधा प्रदान करना।
- 9) सफल उम्मीदवारों को कौशल प्रमाणपत्र जारी करना ।

III. Training Provider Institute (TPI) की भूमिका, पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर

- 1) आधुनिक प्रौद्योगिकी में आवश्यक कौशल की प्रकृति के अनुरूप प्रशिक्षण की आवश्यकताओं के आधार पर कोर्स / पाठ्यक्रम में कौशल प्रशिक्षण प्रदान करना ।
- 2) उम्मीदवारों की योग्यता, कौशल परीक्षण, योग्यता परीक्षा या संस्था अंतर्गत संचालित कोर्स की

विशिष्ट आवश्यकताओं के आधार पर, निर्धारित चयन मापदंड तय करते हुए युवाओं का चयन करना।

- 3) NSQF आधारित कोर्स /जॉब रोल्स के मापदंडों के अनुरूप प्रशिक्षक एवं प्रशिक्षण संचालन हेतु प्रशिक्षण कक्ष, लैब, कार्यशाला, औजार, मशीन, उपकरण अधोसंरचना की व्यवस्था सुनिश्चित करना।
- 4) संस्था में प्रशिक्षण के लिए योग्य प्रशिक्षक, पर्यवेक्षक और सहायक कर्मचारी की व्यवस्था करना ।
- 5) समस्त प्रशिक्षण बैच के लिए CSSDA पोर्टल में प्रशिक्षण प्रारंभ तिथि से पूर्व प्रशिक्षणार्थियों का विवरण अपलोड करना ।
- 6) प्रशिक्षण, आवास, भोजन, मूल्यांकन इत्यादि की सम्पूर्ण व्यवस्था करना ।
- 7) प्रति प्रशिक्षणार्थी न्यूनतम 50 Sq. feet के आधार पर आवासीय व्यवस्था किया जाना, जिसमे हितग्राहियों के रहने योग्य साधन एवं सुविधाएँ उपलब्ध हों ।
- 8) आधुनिक प्रौद्योगिकी अनुरूप NSQF आधारित कोर्स नहीं होने की स्थिति में आवश्यकतानुसार प्रशिक्षण के लिए नवीन कोर्स डिजाइन एवं विकसित करना, विकसित किये गए कोर्स के लिए सैद्धांतिक और प्रायोगिक प्रशिक्षण घटकों की अवधि घंटों में परिभाषित करते हुए राज्य कार्यालय को स्वीकृति हेतु अग्रेषित करना ।
- 9) संस्था में लागू अनुशासन, उपस्थिति, छुट्टी और अन्य नियमों एवं शर्तों के बारे में प्रवेश के समय प्रशिक्षणार्थियों को जानकारी प्रदान करते हुए लिखित रूप में सूचित किया जाना ।
- 10) CSSDA के विनियम एवं जारी दिशानिर्देशों एवं समय-समय पर जारी किए गए संशोधन/ अधिमूचना का पालन करना ।

IV. वैधता

यह अनुबंध तीन वर्ष की अवधि के लिए वैध होगा । TPI का प्रशिक्षण कार्य संतोषजनक होने की स्थिति में अनुबंध (MoU) को अधिकतम 3 वर्ष की अवधि के लिए उत्तरोत्तर वृद्धि किया जा सकता है, अनुबंध की अवधि में वृद्धि दोनों पक्षों के बीच आपसी सहमति से किया जा सकता है ।

V. मध्यस्थता करना

इस अनुबंध (MoU) के उल्लंघन की स्थिति में CSSDA और पं. रविशंकर शुक्ल विश्वविद्यालय, रायपुर समाधान के लिए उचित प्रयास करेंगे। मुख्य कार्यपालन अधिकारी, छत्तीसगढ़ राज्य कौशल विकास प्राधिकरण (CSSDA) का निर्णय अंतिम एवं दोनों पर बाध्यकारी होगा । मध्यस्थता या निर्णय पर असंतुष्ट होने पर प्रकरण पर सुनवाई की स्थिति में मध्यस्थता हेतु स्थान जिला एवं सत्र न्यायालय रायपुर, छत्तीसगढ़ होगा।

VI. अनुबंध/एमओयू की समाप्ति

पूर्व से संचालित प्रशिक्षण बैच के हितग्राहियों के प्रशिक्षण को प्रभावित नहीं करने की शर्त पर CSSDA एवं TPI में से किसी भी एक पक्ष द्वारा 03 महीने का नोटिस देते हुए अनुबंध को समाप्त किया जा सकेगा।



VII. अन्य शर्तें

- आपसी सहमति से संस्था को प्रति प्रशिक्षणार्थी प्रतिमाह प्रशिक्षण राशि निम्न तालिका अनुसार दिया जायेगा। प्रशिक्षण अवधि एक माह से कम अथवा अधिक होने की स्थिति में प्रशिक्षण राशि की गणना यथानुपात (Pro rata Basis) के आधार पर की जायेगी।

AGREEMENT BETWEEN BHABHA ATOMIC RESEARCH CENTRE (BARC), MUMBAI AND Pt. RAVISHANKAR SHUKLA UNIVERSITY, RAIPUR, CHHATISGARH, FOR SETTING UP OF 'AKRUTI KENDRA' FOR PROMOTION OF BARC SPIN OFF TECHNOLOGIES AND TO START UP IN RURAL AND URBAN SECTOR (UNDER THE FRAMEWORK OF DAE SOCIETAL INITIATIVE)

An Agreement made between the President of India, acting through and represented by the Associated Director, Knowledge Management Group, Bhabha Atomic Research Centre, Trombay, Mumbai - 400 085, Maharashtra, Department of Atomic Energy (DAE), Government of India (hereinafter called 'BARC', which expression shall include its successors-in interest and assigns), of the first part

AND

Pt. RAVISHANKAR SHUKLA UNIVERSITY, RAIPUR, CHHATISGARH, INDIA (hereinafter called **PRSU, RAIPUR** which expression shall include its successors-in interest & assigns) of the other part.

PREAMBLE

Whereas BARC is a premier multidisciplinary R&D organization under the Department of Atomic Energy, Government of India, engaged in research with the objective of generating knowledge and technique for nuclear power generation, advancement of science, use of radioisotopes in industry, health and agriculture, research in frontier areas of science and technology. Under the framework of DAE societal initiative, based on the development of Non-Power Applications (NPAs) and Spin-off technologies (Spinoffs) in medical, food preservation, waste management, other industrial and rural applications at BARC, a structured programme has been evolved for Advance Knowledge for Rural and Urban Technology Implementation (AKRUTI) for techno economic growth of rural areas, as one of the many schemes for Large-Scale Deployment of NPAs and Spinoffs. AKRUTI programme is operational in various places and surrounding villages in India. AKRUTIs operated through NGOs have demonstrated the usefulness of BARC technologies and scope for techno-preneurship in rural sector. AKRUTI Kendra would encourage the interested technoprenures to have the first-hand experience of BARC Technologies at the facility run by Academic Institutes.



The University has created its mark as a Centre of Excellence in the field of higher education by imparting quality education along with developing skills amongst the youth of the state and country.

PRSU, RAIPUR expressed their desire to set up AKRUTI Kendra based on BARC technologies for rural sector. **PRSU, RAIPUR** who showed willingness to demonstrate, deploy and adapt these technologies contained in AKRUTI Kendra to create sustainable and income generating activities villages. BARC and **PRSU, RAIPUR** agree to take **Advanced Knowledge for Rural and Urban Technology Implementation (AKRUTI)** initiative by deployment of technologies through AKRUTI Kendra in the rural and urban sector.

Whereas PRSU, RAIPUR is desirous to set up AKRUTI Kendra for deployment of technologies in Rural and urban sector in India.

Whereas PRSU, RAIPUR has requested BARC and BARC has agreed to set up AKRUTI Kendra for promotion and deployment of BARC spin off technologies in interim area and exclusively in Rural sector of India.

Now, Therefore, it is hereby agreed by and between the parties that BARC shall permit **PRSU, RAIPUR** to establish the AKRUTI Kendra and grant **PRSU, RAIPUR** a license to utilize the technologies contained in AKRUTI Kendra for the deployment exclusively in Rural sector of India on terms and conditions hereinafter contained.



1. This Agreement shall supersede all prior correspondence, documents or Agreements, either **PRSU, RAIPUR** or verbal between BARC and **PRSU, RAIPUR** in respect of the Technologies listed in Annexure-A hereto.

2. SCOPE OF AGREEMENT

This Agreement covers the modalities, terms and conditions of demonstration and deployment of technologies contained in AKRUTI Kendra at no cost to BARC on approval of BARC.

3. GRANT OF LICENCE

By this Agreement BARC grants a non-exclusive revocable license to **PRSU, RAIPUR** to demonstrate the BARC developed technologies for 3 years from the date this Agreement becomes effective as per the terms and conditions stipulated in this Agreement. The AKRUTI Kendra can become a legal entity after registration for continuing its activities on commercial basis.

4. RESPONSIBILITIES OF BARC AND MODE OF DEPLOYMENT

4.1 AKRUTI KENDRA TECHNOLOGY DOCUMENT (AKTD)

BARC agrees to supply the technologies for rural deployment, in the form of documents, drawings, literature and advice as detailed in the AKRUTI Kendra Technology Document (AKTD), which will be handed over to **PRSU, RAIPUR** at the time of signing of this Agreement. The composition of the 'AKTD' is given in Annexure-A.

4.2 Technical Guidance & Consultancy

PRSU, RAIPUR shall make necessary arrangements for residential accommodation, TA/DA etc. as per their entitlement for the above deputed personnel during the consultancy.

4.3 Training

Training to instructors of AKRUTI Kendra would be by BARC on selected technologies for which the institute can make infrastructure available to provide training facility. Accommodation for the instructors deputed by the institute for training at BARC will be provided as per the availability of guest house for accommodation.

5. FINANCIAL ARRANGEMENT

PRSU, RAIPUR shall create facility using own resources, no financial support is given by BARC and no license fee to be payable by **PRSU, RAIPUR** to BARC.

6.0 RESPONSIBILITIES OF ACADEMIC INSTITUTE

- 6.1 **PRSU, RAIPUR** is responsible for execution and co-ordination of all AKRUTI activities at their end.
 - 6.2 During the effective period of this Agreement, BARC reserves the right to inspect and test the technologies deployed by **PRSU, RAIPUR** and also to inspect the working places as may be felt necessary by BARC.
 - 6.3 **PRSU, RAIPUR** shall obtain necessary local statutory clearances if required for any activity to be carried out under this Agreement.
 - 6.4 **PRSU, RAIPUR** shall support in spreading the BARC's concept of AKRUTI Programme through villages on its own.
 - 6.5 **PRSU, RAIPUR** shall also be encouraged to deploy new technologies developed by BARC for rural and societal importance on mutually agreed terms and conditions and support individuals to register as a firm or legal entity.

1. Purpose

The goal of the MOU is to foster collaboration provides opportunities to facilitate the advancement of expertise and knowledge based on reciprocity, best effort, mutual benefit, and frequent scientific interactions. - 2.3. Training program for faculty, staff, students and technical personnel within the areas of co-operation will be undertaken at the two institutions.

3. Areas of Co-operation

The areas of co-operation will be defined and modified from time to time by the co-ordination committee set up for the purpose and will generally encompass the areas in Water Resources Engineering / Environmental Engineering / Geomatics and equivalent etc.

- 3.1. CSVTU, Bhilai shall nominate the coordinator for each identified area of cooperation. CSVTU, Bhilai may nominate more than one Coordinator, if needed.

4. Co-ordination Committee

- 4.1. The following will constitute the Coordination Committee to monitor and review the collaborative programme between the two institutions:
- Hon'ble Vice-Chancellor, CSVTU Bhilai and/or his nominee(s)
 - Hon'ble Vice-Chancellor, Pt. RSU, Raipur and / or his nominee(s)
 - HODs of the concerned department(s) from both of the Institutions to be invited whenever needed
- 4.2. The Co-ordination Committee shall:
- Review the progress of the identified programmes (at least once a year)
 - Consider the new R&D proposals for joint collaboration and implementation on case-to-case basis including IPR and financial arrangements.
 - Consider the addition/deletion of areas of co-operation between the two Institutions during review.
 - Consider the continuance of the MoU.

5. Project implementation & Budgeting

- 5.1. Any research and consultancy should be initiated by any of the both Universities shall be treated as leading university for executing the consultancy work for every project.
- 5.2. Both the universities shall take the responsibility to execute and finish the entire project on time and as per client's requirement.
- 5.3. The two universities jointly decide the survey/consultancy and project charges on their own based on their institutional rules and regulation. And the invoice will be raised by the leading university.
- 5.4. The leading university has responsibility to share the revenue generated to the partner university based on quoted charges and the taxes and/or TDS deduction shall be done by government norms.
- 5.5. All fees, service charges/taxes/GST and other charges that shall be levied from clients will be as per government norms. Or

All fees, service charges/taxes/GST and other charges that shall be decided by Co-ordination Committee in such a manner so that project will maintain its self-sustainability as well as recover its financial investment.

- 5.6. The revenue generated by all types of joint surveying/consultancy/technical services should be distributed to both the Universities:

If the CSVTU Bhilai is leading institute then it is their responsibility to deposit the generated revenue to GWRM-PRSU based on quoted charges and vice-versa. However, both Universities must follow the government guidelines for deducting the income tax TDS and GST TDS.

Access to laboratory, library and other supporting facilities for jointly supervised Diploma / PG Diploma / B.Tech / MSc. / M.Tech students (in the areas of mutual interest) and a limited number of already registered Diploma / PG Diploma / B.Tech / MSc. / M.Tech students generally stationed at CSVTU Bhilai and GWRM-PRSU, will be provided by both Institutes. However, the supervision confirmation should be taken by the Institutional head(s) or Hon'ble Vice Chancellor(s).
- 6.4. A total of 3 (three) and 5 (five) selected students out of bachelor degree and master degree respectively in the areas of specialization of Water Resources Engineering / Environmental Engineering and equivalent will be allowed for project work at CSVTU Bhilai and GWRM-PRSU depending upon the availability of bench space. The students will work in the areas of mutually agreeable subject areas identified by the both Universities.

- 7.2. GWRM-PRSU & CSVTU Bhilai will be joint holders of the intellectual property Right (IPR) / Patents flowing out of joint work. The decisions on ownership, licensing, costs, royalties, etc. shall be discussed and made by Co-ordination committee and the coordination Committee recommendations shall be processed in accordance with the framework of IP guidelines and rules governed by individual party at GWRM-PRSU and CSVTU Bhilai. These decisions shall be specified and detailed in individual project/activity specific agreements that will follow under this MoU.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called the MoU) is entered into on this 19th day of May two thousand twenty-two by and between the President of India acting through the Director, Atomic Minerals Directorate for Exploration and Research (AMD), a Constituent Unit of Department of Atomic Energy (DAE), Government of India (hereinafter called "AMD" which expression shall mean and include its successors in interests and assigns) on the **ONE PART;**

AND

The Pt. Ravishankar Shukla University, Amanaka, GE Road, Raipur established under the UGC Act and acting through its Vice Chancellor/ Registrar (herein after called the "University" which expression shall mean and include its successors in interests and assigns) on the **OTHER PART.**

1.0 Preamble:

1.1 Atomic Minerals Directorate for Exploration and Research (AMD) is a premier National Research Centre under the Department of Atomic Energy (DAE) with the primary mandate of exploration and research for atomic minerals required for the country's nuclear power programme. AMD has a big pool of scientists in Geology, Geophysics, Nuclear Physics, Chemistry, Electronics, Instrumentation and Engineering disciplines. AMD is interacting closely with Universities and other Academic Institutions for promotion of research in the fields of Earth Sciences, Analytical Chemistry, Electronics, Instrumentation, etc. Apart from this, AMD is also

extending training/ dissertation/project work for the students of Universities for their partial fulfillment of their courses.

- 1.2 **The Pt. Ravishankar Shukla University** is the largest and oldest institution of higher education founded in 1964. PRSU was set up to impart knowledge in the realm of higher education and research. The Vision of the PRSU is to prepare the young generation for participating in building of a peaceful world society based upon the cherished values of democracy, equality, social justice, plurality and human dignity. The mission of PRSU is :
- a. To Develop the University as a centre of excellence for higher education at national and international level.
 - b. To deepen understanding of the students about the greater purpose of life and instill in them the value of self- esteem and self-reliance:
 - By providing world-class education through university teaching department and schools.
 - By promoting qualitative research in university schools and affiliated colleges.
 - By creating environment conducive to overall development of students.

2.0 Scope and objectives:

- 2.1 AMD being an exploration agency, has generated lot of data which is advancement in the earth science, which can be used for further research and pursuance of higher degree. Therefore, AMD encourages its scientists to pursue research leading to various degrees viz. M.Tech., Ph.D and D.Sc., on a topic relevant to its exploration activities. This MoU would help scientists to get involved for further research through enhancement of knowledge available in Universities.
- 2.2 AMD's professional experience in the field of Geology, Geophysics, Nuclear Physics, Isotopic Dating, Analytical Chemistry, etc. can be shared with the students of the University in the form of lectures, mentoring of research scholars and AMD Studentship Programmes aimed at optimum utilization of resources available with AMD.
- 2.3 Similarly, the postgraduate and research students of various teaching departments of PRSU viz. Electronics & Photonics, Chemistry, Physics, Environmental Science, Life Sciences, Computer Science, Geology & WRM, Pharmacy and Center for Basic Sciences can enhance their knowledge and skill through academic exchange programmes.
- 2.4 Realizing the above objectives, the Parties hereto have agreed to create a long term partnership in Research, Education and Training including undertaking of collaborative Research in the areas of mutual interest supported by funding through the respective institutions according to the broad framework set forth in this Memorandum of Understanding to facilitate advancement of knowledge on the basis of reciprocity based efforts, mutual benefits and regular interactions and monitoring in the following modes of collaboration, within the framework of the rules and regulations of the respective Parties to this MoU:
- (a) exchange of information on Research, Teaching, Learning materials and other literature relevant to the educational and Research programmes envisaged under this MoU such as earth sciences, analytical chemistry, electronics, instrumentation, geological, geophysical survey, mineral exploration, etc.;

- (b) joint proposals and engagement in research or training programmes while extending invitations to each others personnel/faculty to participate therein;
- (c) exchange on reciprocal basis, student/personnel at under graduate, graduate, doctoral levels for specified periods for the purposes of education and/or research;
- (d) providing opportunities for the personnel of both the Parties and the students to use to the maximum, the expertise and facilities available in both the Organizations through training and through exchange of thoughts and research results, academic research and training materials, etc.; and
- (e) sharing experience and expertise of both the Parties for mutual benefits.

3.0 Duration of MoU, Extension and Termination:

- 3.1. This MoU shall be valid for a period of 5 (five) years from the date of its signing.
- 3.2. This MoU may be extended for a further period of up to 5 years by mutual consent which will be in writing.
- 3.3. This MoU may be terminated by either Party by giving a written notice of not less than 3 months prior to the desired termination date to the other Party by mutual consent. However, both Parties agree that notwithstanding the termination, all continuing obligations to students, scholars, staff/ personnel of both Parties, funding bodies or other entities under this MoU shall be met in full, subsequent to the notice of termination.
- 3.4. The termination of this MoU shall not affect the rights or obligations of either party regarding any binding offer or firm obligation approved and agreed to by the Parties prior to the notice of termination.
- 3.5. The termination of this MoU shall not invalidate any of the actions taken by either Party in good faith under the force of this MoU prior to such notice of termination.


4.0 Amendment/Modification:


No amendment to, or modification of, this MoU may be made except by written mutual consent between the Parties.

5.0 Duties and Responsibilities of AMD:

- 5.1. AMD will permit the exchange of resource personnel between AMD and the University for Specialized Lectures and practical demonstration. AMD will offer services to the University without any honorarium or compensation of any kind, on mutual understanding basis.
- 5.2. AMD will invite teachers and students from the University for participation in various Seminars / Symposia / Workshops in AMD, Hyderabad. No registration fee will be charged upto five participants approved by the University authorities.
- 5.3. AMD will facilitate participation of M.Sc., M. Tech. & M. Sc. Tech students (Geology and Geophysics disciplines) in the AMD-Studentship Programme (AMDSP) with stipend at the rates prescribed and notified by AMD from time to time. A certificate of participation will be issued to such students. A copy of the prospectus on AMDSP as on date of signing of this MoU is annexed to this MoU and shall form part and parcel of this MoU. The terms and conditions of the AMDSP are subject to change from time to time and shall be binding on the University.

- 5.4 AMD will facilitate participation of B.E./ B.Tech. (Electronics & Instrumentation, Civil, Mechanical and Electrical) and M.Sc./ M.Tech. (Physics, Chemistry, Geology, Geophysics disciplines) students of the University to pursue their project work in AMD's Laboratory/Field are as ranging from one month to two months duration. A certificate of participation will be issued to such students.
- 5.5 AMD will offer core samples and facilities in the core library at AMD, Hyderabad to research scholars of the University for pursuing research, if desired for joint investigations, subject to the provisions of the Confidentiality and Non-Disclosure Agreement referred to in para 8.1 hereinafter as well as the Atomic Energy Act, 1962 and the Rules made there under.
- 5.6 AMD will encourage the University to take up research and development projects of AMD's interest, funded by / through the Board of Research in Nuclear Sciences (BRNS), an advisory body of the Department of Atomic Energy, Government of India in which AMD will offer its scientists to act as Principal Coordinators. AMD will not, however, be involved in any manner in procurement of specialized/specific equipment for any BRNS project, which has to be managed in accordance with the BRNS guidelines stipulated for Principal Investigators (PI).AMD also will not have any role in the financing of such projects by BRNS and the same will be governed by BRNS rules and guidelines.
- 5.7 AMD will provide the knowledge based services of its scientists for evaluation of Graduate, Post-Graduate students and Ph.D. scholars if required, as per the rules of the University.
- 5.8 AMD will identify internal supervisors in AMD for the officer / staff who qualify for registration of Ph.D./D.Sc. in the University. The Internal supervisor will be in addition to the University guide for carrying out research and such internal supervisor identified by AMD shall be acceptable and binding on the University.

6.0 Duties and Responsibilities of the University:

- 6.1 The University will permit the exchange of resource personnel between AMD and the University for Specialized Lectures and practical demonstration. The University will offer services to AMD without any honorarium or compensation of any kind on mutual understanding basis.
- 6.2 The University will recognize AMD as a Research Centre to pursue research leading to M.Tech. /Ph.D./D.Sc. AMD scientists who prefer to pursue research in the University will be given relaxation, as may be possible, from the mandatory course work as prescribed by the University. Such scholars will be permitted to utilize laboratory facilities, library and online resources of the University.
- 6.3 The University will furnish to AMD, a copy of the Ph.D. thesis submitted by the research scholars who have used the facilities of AMD under this MoU.
- 6.4 The University will arrange lectures on specialized subjects to trainees of BARC Training School as well as the scientists and staff of AMD/DAE, as and when requested by AMD.
- 6.5 The University will offer their services to AMD in technical review of research papers and teaching materials for trainees.

- 6.6 The University will consider expertise available in AMD for the nominations in academic and scientific committees of the University for the advancement of science.
- 6.7 The University will also consider participation of AMD's Scientists in National level research projects undertaken by the University, for mutual benefit. AMD will not, however, participate in any consultancy projects which involves monetary benefit to the University or of commercial nature.
- 6.8 The University will extend all necessary and possible help to AMD in implementation of DAE's societal programmes such as the "AKRUTI Technology Package for Rural Deployment" and any other such programmes developed by DAE in future for societal developments. The University will also extend necessary and possible support to the public outreach programmes of DAE for propagating ideas of "**Safe and Clean Nuclear Energy in India**".
- 6.9 The University will invite AMD scientists for workshops, special lectures, seminars, etc. on subjects of mutual interest. No registration fee will be charged for such events from AMD upto five participants from AMD.
- 6.10 The University personnel shall comply with all the requirements, rules and regulations of AMD including safety, health, security, access and operational practices, when they are in AMD complexes.
- 6.11 The University shall not use AMD's/DAE's name, logo, etc., for the purpose of publicity through any public media like press, radio, television, internet etc. without the prior written permission from AMD / DAE authorities. This clause also mutatis mutandis apply to the scholars, students, contractors, sub-contractors, consultants, advisors, etc. of the University and the university shall be vicariously liable for any breach of this condition by any of these functionaries, in addition to these functionaries being individually liable for such breach.


7.0 Financial and other Obligations:


- 7.1 This MoU does not commit any specific financial obligation or liability on either Party. Each Party shall be responsible for its own costs in connection with all matters relating to the collaborations under this MoU except to the extent specifically mentioned in this MoU. All the expenses on implementation of the programmes under this MoU incurred/ to be incurred by the Parties such as travel expenses, personal expenses, per diem, expenses on accommodation, health etc. shall be borne by the respective Party. However, in case of invited lectures, all such expenses of the invitee shall be borne by the inviting host party. In case of external funding of any programme, under this MoU, is considered necessary, either Party, by mutual consultation, may explore the same.
- 7.2 Nothing in this MoU constitutes or shall construe a Party as the partner, agent, employee or representative of the other Party. A Party to this MoU must not act independently of the other Party and does not have the right or power to commit the other Party on any matter or to incur any obligation on behalf or pledge the credit of, the other Party without the prior written approval of the other Party.

8.0 Confidentiality and Non-Disclosure of Information:

- 8.1 The Parties to this MoU agree that in general, there is no intention to share any confidential information or proprietary information in any collaboration under this MoU. At the same time, all information and documents to be exchanged pursuant to

this MoU will be kept confidential by the parties and will be used subject to such terms as each party may specify. The parties will not use the information for purpose other than that specified without the prior written consent of the other party.

- 8.2 It is further agreed that in the event of any need to share or disclose any such information for the purpose of implementation of the programmes under this MoU, all such information shall remain the exclusive property of the disclosing party. The parties agree that this agreement and the disclosure of the Confidential Information do not grant or imply any license, interest or right to the Recipient in respect of any intellectual property right of the other party.
- 8.3 Unpublished information, whether oral, in writing or otherwise, discovered or conceived by the scientists or technicians and exchanged under the provision of this MoU will not be transmitted to any third party, unless otherwise agreed to by the parties in writing and unless due approval of the competent authority in AMD is specifically conveyed in writing.
- 8.4 The provisions of this clause shall continue to be in force even after expiry or termination of this MoU, except to the extent of information as may be brought in the public domain by way of lawful publication of research results, etc.
- 8.5 Any contravention of the "Restricted information" categories under Section 18 of the Atomic Energy Act, 1962 and "Official Secrets" under Section 5 of the Official Secrets Act, 1923 and rules made there under by the students / scholars and employees of the Parties or by any contractor, sub-contractor, consultant, advisor or the employees of the contractor/Agency will invite penal consequences under the aforesaid legislations. This clause shall also *mutatis mutandis* apply to the scholars, students, contractors, sub-contractors, consultants, advisors etc. of the University and the university shall be vicariously liable for any breach of this condition by any of these functionaries, in addition to these functionaries being individually liable for such breach.

9.0 Indemnification in case of Liabilities:


In case of any accidental death or injury or loss, including loss of property, of any kind to the students/scholars/employees of each Party or to any other person engaged by either Party for the purposes of this MoU while in the premises of the other Party / or during joint field traverses, neither Party nor its employees shall have any liability to the other Party or towards such students/scholars/employees. Each party hereby indemnify the other in this regard.

10.0 Co-ordination and Monitoring:

Both AMD and the University will nominate and designate one person each from the respective Party who will be responsible for the co-ordination and implementation of this MoU. A joint committee comprising two members from each Party and the coordinators so nominated shall monitor the academic benefits to both the institutions and progress of the achievements during the implementation of this MoU and shall recommend the further course of action from time to time. The committee shall meet at least twice a year or more number of times as may be required.

11.0 Intellectual Property Rights:

- 11.1 Each Party acknowledges that the Participating Researchers may engage only in general, collaborative activities involving basic, non-proprietary research during






exchange visits under this MoU. The Parties do not intend for the Participating Researchers to create or develop new intellectual property as a result of such visits. If intellectual property is created or developed by Participating Researchers under this MoU, the Parties will negotiate in good faith to resolve the issues including but not limited to ownership, responsibility for patent or other statutory protection and licensing.

- 11.2 If specific collaborative research Projects are identified by either Party, the same shall be decided by mutual discussions. In such an event, the Parties to this MoU shall enter into a separate written agreement ("Specific Collaborative Research Project MoU") before commencing any research activity, setting forth therein all the requirements, each Party's contributions, deliverables and commitments. Such Specific Collaborative Research Project MoU will also delineate the Parties' rights and obligations and will address, among other things, sources of funding and intellectual property rights. Each Party shall inform its Participating Researchers that they are responsible for reporting to their respective Coordinating officer regarding any proposed specific collaborative research projects that may arise from their visits and their interactions with one another under this MoU, prior to initiating projects or applying jointly for external funding for such projects. Each Party also shall inform its Participating Researchers of their obligations to abide by all regulations, policies and procedures of their employing institutions regarding the disclosing and handling of intellectual property and developed technologies that may arise under this MoU or under any Specific Collaborative Research Project MoU.

12.0 Jurisdiction of Courts:

The Courts having jurisdiction at Hyderabad and the Honourable High court for the State of Telangana at Hyderabad shall have the exclusive jurisdiction on matters arising out of this MoU.


13.0 Arbitration:

- 13.1 Notwithstanding clause 12.0 hereinabove, any differences of opinion, disagreement or dispute arising out of or in the course of implementation of this MoU, shall be amicably settled by mutual discussions between the Heads of both the Parties to this MoU. In the event no settlement could be arrived at by mutual discussions as above, the differences of opinions, disagreement or dispute shall be referred to the sole Arbitration of an Arbitrator appointed by Secretary, Government of India, Department of Atomic Energy. The award of the Arbitrator shall be final and binding on the parties to this MoU.
- 13.2 Performance under this MoU shall not be or stand suspended or terminated due to initiation or continuation of any arbitration proceeding and no payment due under this MoU to any Party shall be withheld unless such payment constitutes the subject of such arbitration proceedings. The venue of arbitration shall be such as the arbitrator at his discretion may determine.
- 13.3 Subject as aforesaid, the Arbitration and Conciliation Act 1996, and the rules there under and any statutory modifications thereof for the time being in force shall apply to the arbitration proceedings under this clause. However, all payments due to AMD will be made during the period of dispute, unless that itself is the point of dispute.
- 13.4 In this clause the expression "Secretary, Government of India, Department of Atomic Energy" includes, if there be no such Secretary, Government of India, Department of Atomic Energy the officer who is for the time being the Administrative head of the Department of Atomic Energy, whether in addition to other functions or otherwise.







MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING ("MoU") is signed on **June 27, 2024** ;

Between

Pandit Ravishankar Shukla University, Raipur, Chhattisgarh (hereafter referred as "PRSU") and the CSIR-National Geophysical Research Institute, Hyderabad (hereafter referred as "CSIR-NGRI").

PREAMBLE

Pandit Ravishankar Shukla University (PRSU) was founded in 1964. It is named after the first chief minister of erstwhile Madhya Pradesh, and is the oldest university of Chhattisgarh. The university is located at Raipur with a campus of 300 acres. There are twenty-nine postgraduate teaching departments. The university is known for its academic excellence, and attracts students from Chhattisgarh and neighbouring states. PRSU plays an important role through active research in generating innovative ideas across various fields. It offers opportunities for students to collaborate with experts from diverse disciplines through its Innovation, Incubation and Internship programs. The university significantly influences educational, cultural, and economic landscape of Central India.

The National Geophysical Research Institute, Hyderabad (NGRI), is a constituent laboratory of the Council of Scientific and Industrial Research (CSIR), New Delhi, and a leading research institute engaged in carrying out multidisciplinary R&D programs in Earth System Sciences covering basic, applied and computational aspects of geophysics for natural resources and environmental studies. The extensive research programs and developmental activities have provided the benefits of its S&T prowess for the well-being of the Indian society and played a pivotal role in the exploration of hydrocarbons, minerals and groundwater resources, engineering geophysics, seismology, geodynamic studies and geophysical instrumentation.

1.0 Objective

Pandit Ravishankar Shukla University (PRSU) and the CSIR- National Geophysical Research Institute (CSIR-NGRI), here-in-after called "the parties", agree to coordinate and collaborate in the following areas:

- a) R&D in mutually identified thrust areas of geophysics and geology
- b) Promoting CSIR-NGRI - PRSU joint research programs funded by outside agencies, such as the SERB/DST, Ministry of Earth Sciences, Department of Space, etc.
- c) Consultancy

- d) Intellectual Property Rights
- e) Any other areas of mutual interest

2.0 Terms of Collaboration

- (a) PRSU and CSIR-NGRI agree to enter into scientific project agreements on a case-to-case basis, with a defined objective, scope of work, mutual obligations, terms and conditions, financial arrangements, intellectual property rights, and similar contractual obligations.
- (b) Sharing expertise and available research facilities in mutually identified thrust areas of S&T, especially applicable to Earth Resource Exploration: Mineral exploration (in particular geophysical exploration), groundwater studies, natural hazard studies, evolution of crust and lithosphere.
- (c) To develop and implement modelling techniques and computational aspects of geophysics and geology for natural and environmental resources using infrastructural/analytical/technical facilities and expertise available to both parties.
- (d) To promote scientific relationships and mutual interaction among scientists, faculty through exchange visits and sharing of scientific literature. During exchange visits by scientists and faculty, the parties will provide the infrastructural facilities at concessional rates.
- (e) Insofar as any third party is concerned, this memorandum of understanding (MoU) will be valid only when a letter from PRSU and CSIR-NGRI is enclosed specifically expressing concurrence and an officer identified by name representing PRSU/CSIR-NGRI, who will be responsible for the specified project.
- (f) In case one of the parties gets a consultancy project by projecting this MoU, a liability is created immediately with respect to the royalty/premium to be shared by both parties. Both parties agree with this liability. The exact amount of liability will be determined after mutual consent by both parties based on CSIR-NGRI and PRSU guidelines.
- (g) All student exchange activities will be decided on a case-to-case basis.

3.0 Disclaimer

PRSU and CSIR-NGRI do not intend this MoU to constitute, create, give effect to or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party hereto shall act as an independent entity, and neither shall act as an agent of the other organizations for other purposes. None of the parties has the authority to bind the other parties.

4.0 Non-exclusivity

This agreement, reflected by the provisions of this MoU, is non-exclusive, and both parties can enter into cooperative agreements with other parties to suit their organizational skills.

5.0 Confidentiality

The parties understand that during their association, they have access to confidential information the other parties provide. Accordingly, the parties agree that such confidential information shall be maintained in the strictest confidence and trust. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU with immediate effect, without the issue of notice period.

6.0 Administration

Both parties will identify coordinator(s) for their respective organizations as and when a specific program is formulated. Vice Chancellor, PRSU or his nominee will be the coordinator representing PRSU. Similarly, the Director, CSIR-NGRI or his nominee will be the coordinator representing CSIR-NGRI.

7.0 Financial Provision

The details of finances will be agreed upon after mutual discussion from time to time, depending on the particular activity.

8.0 Duration

This MoU would remain valid for three years from the date the parties sign it. The MoU shall be reviewed at the end of the second year from the date of signing of this MoU.

Clause 1: THRUST AREA





academic matters, the Director heading the SSCSS shall report to the Vice Chancellor through the Registrar of the PRSU.

- All the day-to-day activities of the SSCSS will be run under the supervision and direction of the Honorary Director of the SSCSS.
- ✓ The Vice Chancellor shall have an authority to oversee the functioning of the said SSCSS and issue guidelines whenever he/she deems it fit and necessary.

Clause 8: FUNDING PATTERN

- The proposed SSCSS will have Corpus fund of Rs. 1.00 crore sanctioned by NCPSEL, New Delhi, vide cheque/D.D. No. 373751 Dated 30.03.2019 of State Bank of India, R.K. Puram, New Delhi.
- The Corpus fund will be deposited in a nationalized bank as fixed deposit so as to earn interest on the same.
- Further, 10% of interest accrued thereon will be treated as capital corpus.
- The activities and the programmes of the SSCSS, including the office expense, will be conducted and organized utilizing the remaining interest amount accrued on the corpus fund deposited.
- PRSU may incur such expenses to such extent on the activities of the SSCSS as approved by the appropriate authorities of the PRSU.
- The Director of SSCSS shall be the competent and controlling authority with power to draw and disburse salary, emoluments and miscellaneous expenses.
- The necessary infrastructure facilities will be made available by the PRSU for running the above SSCSS.
- PRSU would support most of the expenditure involved in human resources by way of redeploying its existing staff to look after the work of the "Sant Shadaram Center for Sindhi Studies".
- An advisory board of Sindhi experts consisting of 3-5 members will be constituted by the Hon'ble Vice Chancellor of PRSU when and where it is required.

Clause 9: TERMINATION

- a. This MoU can be terminated by either of the Parties on six months advance written notice from either side for the violation of any of the terms and conditions of this MoU in writing.
- b. However, if the MoU is terminated for whatsoever reason, the responsibility of each Party shall continue to exist till the completion of the programme to which the students have been admitted before the date of serving the notice of termination.

Clause 10: ARBITRATION

nurture entrepreneurs and provide quality mentorship to steer the entrepreneurial journeys of those interested, by providing incubation, and constant support.

And Whereas

Pt. Ravishankar Shukla University is Chhattisgarh's largest and oldest institution of higher education, founded in 1964, and named after the first chief minister of erstwhile Madhya Pradesh. The University has a sprawling campus in the western part of the capital of Chhattisgarh, Raipur. The main objective of the University has been the creation and dissemination of knowledge

Both the institutions, intending to collaborate and cooperate in various areas of mutual interest, hereby agree to the following terms and conditions:

1. Scope of MoU:

Both the parties in principle agree to work in the following areas of collaboration:

- a. cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests.
- b. collaborate in curriculum development for skill education and General education
- c. provide mutual access to facilities for the academic purposes as mutually agreed between the parties prior to commencement of the activity:
- d. conduct short courses, as mutually agreed in writing between the parties prior to commencement of this activity:
- e. areas of collaboration may be proposed by either institution and may include, but are not limited to:
 - i. Joint teaching, research, or cultural activity;
 - ii. Mobility of faculty, scholars, and students between institutions;
 - iii. Staff professional development;
 - iv. Sharing or creation of educational materials and resources;
 - v. Participations in seminars and academic meetings;
 - vi. Organizing Special Short Term Academic Programs;
 - vii. Exchange of Academic Materials;

- viii. Creation and sharing of electronic instruction media;
- ix. To support skill development and entrepreneurship initiatives;
- x. Any other item agreed in Collaboration Coordination Committee meeting.

Any specific activity developed under this MOU shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals.

2. Commencement and Validity:

2.1 This MOU shall be in effect for a period of FIVE years from the date of signature unless terminated earlier by mutual consent or due to unforeseen circumstances. Either party may request termination of this agreement, in writing, Thirty (30) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.

2.2 A joint evaluation of the MOU will be initiated by the designated representatives six (6) months prior to the expiration date. Following the evaluation, the MOU may be renewed and re-signed for an additional five (5) year period.

2.3 Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.

3 Coordination Committee:

To facilitate this MOU, a DSEU-PRSU Collaboration Coordination Committee (CCC) will be formed. The CCC will be composed of four members from each of the Institutions including one Chair and one Liaison from each Institution. It is the CCC's responsibility to carry out collaboration-related duties and to report to the Vice-Chancellor of both Institutions. The CCC will be notified.

4 Commercials:

Both the Parties shall work out commercials with respect to each individual work plan separately. In no case any financial or academic liability on one party would be transferrable on the other party.

5 Use of Name:

None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising, marketing, endorsement or any other purposes without the specific prior written consent of an authorized representative of the other party as to each such use.

6 Independent Contractors:

Each party is separate and independent and this Agreement shall not be deemed to create a relationship of agency, employment, or partnership between or among them. Each party understands and agrees that this Agreement establishes an independent contractor relationship and that the agents or employees of each respective party are not employees or agents of any other party.

7 Severability:

The provisions of this Agreement are severable, and if any provision of this Agreement is found to be invalid, void or unenforceable, the remaining provisions will remain in full force and effect.

8 Waiver:

The waiver of any breach of any term of this Agreement does not waive any subsequent breach of that or another term of this Agreement.

9 Assignments:

No party may assign this Agreement or any rights or obligations under this Agreement to any person or entity without the prior written consent of the other parties. Any assignment in violation of this provision is null and void.

10 Intellectual Property Rights:

Both parties agree to establish protocols concerning ownership and sharing of intellectual property resulting from collaborative activities.

11 Confidentiality:

All information shared between the parties under this MoU shall be considered confidential and shall not be disclosed to third parties without prior written consent.

12 Terminations:

12.1 In case of breach of contract both parties may, without assigning any reason, terminate this Memorandum of Understanding at any time by giving to the other party three month notice in writing sent by registered post or Speed Post or Courier or may request the re-negotiation of its conditions.

12.2 Without prejudice to any other remedies both Parties shall have the right at any time by giving notice in writing to each other for terminating the Memorandum of Understanding forthwith in any of the following events:

12.2.1 Any of the parties commit the breach of any of the terms or conditions of this Memorandum of Understanding.

12.2.2 Any party enters into liquidation, whether compulsorily or voluntarily (otherwise than for the purposes of amalgamation or reconstruction) or

compounds with creditors or takes or suffers any similar action in consequence of debt or in the case of an individual or a partnership.

12.2.3 Any of the parties are guilty of any conduct which legally is prejudicial to the contract's interests.

12.2.4 No party shall have authority to purport or assign the burden or benefits or charge the benefits of this Memorandum of Understanding without the consent in writing of the other Party.

13 Amendments: Any amendments or modifications to this MoU shall be made in writing and mutually agreed upon by both parties.

This memorandum is executed in the English language in two originals and each party holds one original.

14 Force Majeure

14.1 If the performance of the obligations under this Memorandum of Understanding is prevented by reason of any contingencies, which could have been reasonably avoided and are beyond the control of the parties, the party so affected shall not be liable to the other for damages to the extent of such prevention. Such contingencies include strikes of workers, fire, flood, explosion, riots sabotage, acts of God and war or enemy action.

15 Notice

15.1 Save as hereinbefore otherwise provided, any notice required to be given hereunder shall be sufficiently given to each other if forwarded by registered post, speed post, courier, to the last known postal address of the parties. Every notice shall be deemed to have been received and given at the time when in the ordinary course of transmission, it should have been delivered at the address to which it was sent.

MEMORANDUM OF UNDERSTANDING BETWEEN

ARYABHATTA RESEARCH INSTITUTE OF OBSERVATIONAL SCIENCES (ARIES)

AND PANDIT RAVISHANKAR SHUKLA UNIVERSITY, RAIPUR, CHHATTISGARH (2011)

PREAMBLE

The Department of Science and Technology (DST) and the University Grant commission have realized the need for a close linkage between National Laboratories and the Universities in terms of research and academic activities. It has been seven years since ARIES became an autonomous institute under the DST, Govt. of India. Within this short span of time ARIES has initiated a number of big impact projects in the fields of Astronomy & Astrophysics and Atmospheric Sciences. These include the 3.6-m telescope which is being installed at Devasthal in collaboration with Belgium and ST-Radar project which is being installed at the Manora Peak campus.

School of Studies in Physics and Astrophysics department of Pt. Ravishankar Shukla University (PRSU) has a number of faculties who are engaged in active research in the field of Astrophysics. The University is one of the IUCAA Resource Centres. The areas in which research activities are carried out at the department are; chromospherically active stars, chemically peculiar & variable stars, study of Supernovae, multi-wavelength surface photometry of early-type galaxies mainly to investigate properties of dust in early-type galaxies, galaxies from deep survey field, and theoretical investigations and modeling of galaxies. The University also has a number of small aperture telescopes essential to train M. Sc. and M. Phil. students. It is understood that to enhance the existing observing facilities, the University is setting up a bigger sized (24-inch aperture or higher) optical telescope.

The time is appropriate for ARIES and Pt. Ravishankar Shukla University to indulge in a scientific collaboration so that the younger minds graduating from the University will have a wider facilities to explore and get a flavor of research and developmental activities at an early stage. The close scientific relation between ARIES and the University can achieve an effective synergy. To further strengthen the already existing scientific relations, ARIES and PRSU have decided to sign a Memorandum of Understanding (MoU) as per the terms and conditions mentioned below.



1. GENERAL

2. ARIES scientist and faculty members of Physics Department of PRSU will work towards joint research projects thereby mutually using research facilities developed/ to be developed at ARIES and PRSU.

1.2 ARIES scientist shall participate in the teaching programs in the areas of mutual interest/departmental needs, at the Department of Physics, PRSU upon request and subject to mutual convenience. The proposal to consider ARIES scientist as Adjunct Faculty member to the concerned Department of PRSU may be submitted to the competent authority of PRSU. The Program Coordinators for coordinating the academic activities shall be HOD/Campus HOD of the concerned department from PRSU side and Chairman of Academic Committee of ARIES from ARIES side.

1.3 For supervising research leading to Ph. D. degree, PRSU will recognize and accept those ARIES scientist who has obtained a doctorate degree and published 5 research papers on concerned subject in standard refereed journals and have 5 years post-doctoral research experience.

1.4 ARIES selects students for the Ph.D program through interviews of candidates who are qualified in national eligibility tests (like JEST, CSIR-UGC, GATE and national level exam conducted by ARIES). PRSU will recognize all the students selected by ARIES.

1.5 ARIES conducts rigorous pre-Ph.D course work for the students inducted for the PhD program. The course work includes advanced topics from physics, which enables the PhD students to get acquainted with cutting edge research in the field of Astronomy and Atmospheric Sciences. PRSU will recognize ARIES course work.

1.6 The faculty and students of Physics Department of PRSU shall be allowed to use library, computer and Internet facilities of ARIES subjected to the terms and conditions of ARIES. Scientist and Ph. D. students of ARIES shall likewise be given the above-mentioned facilities at PRSU.

1.7 The faculty and the students of Physics Department of PRSU shall be issued temporary identity cards upon individual requests, by ARIES as per ARIES rules so as to provide them unhindered access to the laboratories and other facilities of the institute.

1.8 Where required, ARIES shall arrange hostel/guest house accommodation for PRSU faculty members and students coming to ARIES for research/collaborative work. PRSU shall also arrange hostel/guest house accommodation for ARIES scientist/research scholars /visiting faculties.



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on this the 05 day of April, 2011 between **Oil and Natural Gas Corporation Limited (ONGC)**, a company registered under the Companies Act 1956, having its registered office at Jeevan Bharti Building, Tower-II, 124 Indira Chowk, New Delhi-110001 and one of its offices at Dehradun (herein after referred to as ONGC which expression shall unless repugnant to the context include its representatives, successors and permitted assignees) of the **FIRST PART** and

Pandit Ravishankar Shukla University, Raipur established under / registered under CG. Univ. Act. 1973 (N-2) Act, having its office at Raipur, Chhattisgarh (hereinafter referred to as PRS University which expression shall unless repugnant to the context include its representatives and successors and permitted assignees) of the **SECOND PART**.

Whereas the PRS University has been established for the purposes, among others, for imparting education in Science, Arts, and the learned professions and of furthering advancement of learning and original research.

And Whereas ONGC is engaged in the business of hydrocarbons exploration and exploitation and has decided to institute ONGC Scholarships in PRS University.

Now Therefore in consideration of the mutual covenants set out in this MOU, the parties hereby agree on the terms and conditions details hereunder:

1. OBJECTIVE:

To strengthen industry-academia linkage by instituting ONGC Scholarships in PRS University for rewarding, encouraging and assisting meritorious students for higher studies in the petroleum upstream related education.

2. RESPONSIBILITIES AND COMMITMENTS:

In the spirit and context of the purpose of this MOU the parties agree to assist each other, to be committed to professional excellence, to communicate on a regular basis and to encourage open dialogue and cooperation between ONGC and PRS University.

3. SCHOLARSHIP

- i) There will be two scholarships in PRS University.
- ii) These scholarships will be called "ONGC Scholarships" and the scholarship holders will be called as "ONGC Scholars".



iii) The department / course and degree for which ONGC Scholarships will be instituted are presented in following table:

iv) The criteria for selection of student for award of ONGC Scholarship, the scholarship amount and scholarship duration will be as follows:

4. OBLIGATION OF PANDIT RAVISHANKAR SHUKLA UNIVERSITY, RAIPUR:

i) The PRS University will select the student for award of ONGC Scholarship in an academic year as per the criteria detailed in 3.iv) above.

ii) The PRS University after the selection of student for ONGC Scholarship will intimate Head ONGC Academy, Kaulagarh Road, Dehradun through a written report giving detail of the student selected. Biodata and photograph of the selected student will also be enclosed with the report.

iii) The PRS University will send a written demand note to Head, ONGC Academy, Kaulagarh Road, Dehradun for release of the fund for two ONGC Scholarships in an academic year for disbursement to the ONGC Scholars.

iv) The PRS University will receive the fund for ONGC Scholarships from ONGC and will disburse the same to the ONGC Scholars regularly.

v) The PRS University will submit the ONGC Scholarship fund utilization report in respect of an academic year to Head, ONGC Academy, 9, Kaulagarh Road, Dehradun confirming that the ONGC Scholar has received the entire ONGC Scholarship amount due to him, before requesting for release of fund for the next academic year.



5. OBLIGATION OF ONGC:

- i). ONGC will award two ONGC Scholarships in the PRS University detailed below:

- ii) ONGC will release the total fund for two ONGC Scholarships (scholarship at a rate of Rs. 5000 per month) in respect of an academic year after receiving the ONGC Scholar selection report and a written demand note from the Registrar of PRS University to Head, ONGC Academy, 9, Kaulagarh Road, Dehradun for release of the total fund for ONGC Scholarships.

6. VALIDITY OF MOU:

This MOU is effective from the academic year 2011-12. The ONGC reserves the right to terminate this MOU at any point of time.

7. DISPUTE RESOLUTION:

In the event of any dispute or difference between the parties hereto, such dispute or difference shall be resolved amicably by mutual consultation or through the good offices of Head ONGC Academy. In case such resolution is not possible, then the unresolved dispute or difference shall be referred to a committee consisting of two members each from ONGC and the PRS University with Director (HR) of ONGC as its head, the decision of the committee shall be binding upon both the parties. Provided, however, any party aggrieved by such decision may make a further reference for setting aside or revision of the decision to the CMD of ONGC whose decision shall bind the parties finally and conclusively.

8. APPLICABLE LAW AND JURISDICTION:

All question disputes or differences arising under out of or in connection with the MOU shall be governed by Indian Laws, both procedural and substantive and shall be subject to exclusive jurisdiction of Courts at Dehradun.

9. AMENDMENT:

This MOU may be amended in writing with the mutual consent of both parties.



10. OPERATION, CONDUCT AND IMPLEMENTATION:

PRS University and ONGC agree to nominate specific personnel for operational, conduct and implementation of this MOU.

IUCAA Centre for Astronomy Research and Development (ICARD)

It is proposed to have IUCAA Centre for Astronomy Research and Development (ICARD) at various Universities and Colleges. The ICARD programme would bring into its fold the various different centres that IUCAA has had in the past.

The primary functions of the ICARDs are:

- 1) To contribute to development of innovative teaching methods designed for Astronomy. This includes development of upto date course structures and new kinds of experiment/data analysis sessions which can be a part of a starting or existing Astronomy course in a University. They will try and inculcate distant learning programs and come up with suggestions as to how they can be implemented.
- 2) To hold frequent workshops/schools/meetings at various levels at the host University/College and at nearby regions.
- 3) To have an active public outreach program for Astronomy.
- 4) To be visiting Centre where nearby Astronomers can visit.

Modes of Functionality:

Funding for these activities may be provided by IUCAA. For each activity (such as seminars, workshops, meetings) the ICARD may make a proposal to IUCAA with a budget for approval. The ICARD may also make other requests (such as setting up a facility for distant learning), which will be considered on a case by case basis. The ICARDs are encouraged to come up with innovative plans to enhance Astronomy in their regions taking into account the local logistics and requirements.

A running expense up to Rs. 30,000 will be provided to each ICARD as per need. This expense will be used for small day to day costs such as a visit by a scientist from another University, consumable stationery etc.

All financial transactions from IUCAA to the ICARD will be made through NEFT transfer to an official account of the University/College/Institute. Earlier IUCAA centres which have had separate accounts in the centre's name, should be terminated and the remaining funds returned to IUCAA. Utilization Certificates and statement of expenditure for the finances provided by IUCAA, will be prepared and sent by the ICARD to IUCAA. The ICARD will also send before February 1st the details of the expenditure incurred in the running costs.

IUCAA will not lend any asset to the ICARD, except as required and sanctioned by specific proposals made and approved by IUCAA. IUCAA assets in earlier IUCAA centres will be disposed/returned/retained through a separate process. ICARDs will have a validity of two years beginning from March 31st of the year of the acceptance of the invitation to become an ICARD. ICARD must provide routine updates and reports of their activities which must be at least once a year. The reports and updates will be displayed in public view in the IUCAA webpage. Renewal of the ICARD after two years will depend on the successful activities undertaken by the Centre.





THE FIRST PARTY and THE SECOND PARTY shall referred as to THE PARTIES or BOTH PARTIES.

The Parties have considered as follows:

- a. The First Party is a state university established on September 29, 1962, has a strong position as one of the major universities, particularly in the Eastern Indonesian Territory, and engages in the fields of education, research, and community services;
- b. Whereas The Second Party is the State Government University that was established on May 01, 1964, and It is one of the largest and oldest and top most institutions of higher education in Chhattisgarh state of India, and engages in the field of Higher education, research and community services. It is a teaching-cum-affiliating university which affiliates about 158 colleges and has 30 University Teaching Departments.;
- c. Whereas Both Parties have considered their common interests in promoting the mutual cooperation in the area of education and research and are desirous of expanding the basis for academic and educational cooperation;
- d. The Parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

ARTICLE I OBJECTIVE

The objective of this Memorandum of Understanding is to develop academic and educational cooperation based on equality and reciprocity and to promote relations and mutual understanding between the Parties. ARTICLE II SCOPE OF COOPERATION

- (2) The parties wish to carry out programs and activities in cooperation with each other;
- (3) The parties may wish to undertake programs in the areas of;
 - a. Teaching activities and exchange of teaching staff and researchers;
 - b. Joint development of research projects;
 - c. Organization of academic activities such as academic conferences, cooperative lectures, special short training courses, seminars, and symposia;
 - d. Exchange of students;
 - e. Exchange of members of technical and administrative staff;
 - f. Shared courses and subjects;
 - g. Dual degrees;
 - h. Internalization and cultural learning;
 - i. Sustainable Development Goals (SDG).

ARTICLE III PLAN OF OPERATION

Both parties recognize that the development and implementation of each academic program (Course) based upon this Memorandum of Understanding will need to be negotiated and agreed upon by Both Parties under a separate agreement (Memorandum of Agreement) prior to the initiation of the particular program and that such activities are carried out in accordance with the laws and regulations of the respective countries.

The Plan of Operation may include, among others, items such as:

1. Elaboration of the responsibilities of each Party for the agreed-upon activities;
2. Schedules for the specific activity;
3. Budgets and sources of financing for each activity; and
4. Any other items deemed necessary for the efficient management of the activity.

**ARTICLE IV
FINANCIAL ARRANGEMENT**

The Parties understand that all financial arrangements associated with the initiative shall be clearly outlined in the Plan of Operation pursuant to Article III, and shall be signed by the authorized representatives of the Parties.

**ARTICLE V
INTELLECTUAL PROPERTY RIGHTS AND DISCLOSURE OF INFORMATION**

1. If either Party wishes to disclose confidential data and/or information resulting from the cooperative activities under this Memorandum of Understanding to any third party, the disclosing Party must obtain prior consent from the other Party before any disclosure can be made; and
2. Any arrangement arising from this Memorandum of Understanding involving intellectual property rights pertaining to research, publication, and/or commercial purposes shall be determined by specific arrangements to be agreed upon by the Parties at the time and included in a formal agreement.

**ARTICLE VI
SETTLEMENT OF DIFFERENCES**

Any disputes arising out of the interpretation and/or the implementation of this Memorandum of Understanding shall be resolved amicably through consultation and/or negotiation between the Parties.

**ARTICLE VII
AMENDMENT**

This Memorandum of Understanding may be amended at any time, by mutual written consent of the Parties. Such amendment shall come into effect on the date as may be determined by the Parties and shall form an integral part of this Memorandum of Understanding.

**ARTICLE VIII
ENTRY INTO FORCE, DURATION AND TERMINATION**



If the extent of the cooperation in individual fields exceeds the frame of this agreement, i.e. if the realization of some of the mutual projects requires material or financial resources, such a situation will be solved ad hoc in a special contract.

IV.


VII.







- Exchange of academic information and materials;
- Publication activities of mutual interest.

Art. 2. The cooperation described above will in every case be dependent upon the availability of necessary fund, either from within both parties or from external sources. Both parties, separately or jointly, will try to allocate sources.

Art. 3. The areas of cooperation include, subject to mutual consent, any programme offered by either party and considered desirable and having potential to contribute to the mission and effectiveness of either party and/or contribute to fostering the cooperative relationship between parties.

Art. 4. The terms and necessary budget for each programme and activity will be described in Letters of Agreement which will be prepared subsequent to this Memorandum of Understanding and signed by both parties prior to the initiation of a cooperative programme or activity. Each programme and activity will be negotiated on an annual basis. Each party will designate a contact person who will be responsible for the implementation of the Letter of Agreement.

The Liasion Officer at Registrar, Pt. Ravishankar Shukla University, Raipur will be:

Art. 4.1 Concerning an exchange programme and collaborative research, the following topics will be arranged with mutual consent:

- Requirements concerning admittance of students;
- Number and duration of the exchanges;
- Aim of the exchange or the collaborative research;
- Facilities offered by each party.

Art. 5. Concerning staff exchange programmes and collaborative research the parties hereby further that:

- Travel and living expenses shall be the responsibility of the visiting participants, unless both institutions agree to alternatives.
- The host part will assist in finding lodging for visiting participants;
- Visiting participants will be responsible for obtaining the necessary insurance coverage (medical, insurance of damage etc.). The host institution cannot be held responsible for any damage suffered or caused by visiting participants. A visiting participant must be able to show the insurance contract on the request of the responsible administrator of the



host institution. Visiting participants will abide by the rules and regulations of the host institution and by local laws.

Art. 6. Concerning student programmes parties also agree that:

- Exchange students studying for one semester or one academic year do not pay tuition and fees (waiver policy), provided that a reciprocal exchange of students is implemented in each academic year, as stipulated below.
- Each academic year one institution will allow no more than 5 students from the other institution to enroll as exchange students. The actual number of students to be exchanged will be determined every year by mutual consultation in advance. However, the exchange of students must be reciprocal, in order that the sending institution's exchange students may benefit from the waiver policy at the host institution.
- If after an initial waiver-free period of 2 academic years (upon signing of the Memorandum of Understanding) the exchange of students is unilateral (without the other institution actually sending students for exchange), the waiver policy may be superseded and exchange students from the sending institution may be required to pay tuition fee to the receiving institution.
- Students enrolled in degree programmes at receiving institution (2 academic years or more) pay tuition and fees, in accordance with the tuition tariffs applied at the receiving institution.
- Expenses for insurance, for travel to and the stay in the host country will be borne by the participating student.
- The departments involved in the exchange at receiving institution will provide for academic counseling in order to ensure that all academic courses are recognized by the sending institution.
- Information concerning the types of training involved and their mode of access, the diplomas and/or certificates that may be granted, and information about research programmes as well as those groups which are involved in it, will be systematically exchanged between the two parties.

Art. 7. The present Memorandum of Understanding is signed for 5 years (Five years), starting from the date of its signature by both parties, and is renewable by tacit agreement for equal periods. Either party may terminate this Memorandum of Understanding by means of a certified (registered) letter received by the other party six months prior to the end of any calendar year.






